**ORDER GRANTING
APPROVAL OF ELECTRIC
SERVICE TERRITORY
BOUNDARY AGREEMENT**

On January 7, 2014, the South Dakota Public Utilities Commission (Commission) received a filing from the Commission's Staff (Staff) regarding an electric service territory boundary agreement between Lake Region Electric Association, Inc. and Codington-Clark Electric Cooperative, Inc. This filing was made pursuant to current efforts of the PUC to verify electric territory mapping data for conversion to electronic format and use in a Geographic Information System (GIS) database. With the assistance of the above-referenced utilities, Commission Staff has confirmed the service territory boundary shared by these utilities and has prepared updated mapping information. Commission Staff asks for approval of the agreement to update official mapping data to properly reflect the service territory boundaries shared by the utilities in this docket.

On January 9, 2014, the Commission electronically transmitted notice of the filing and the intervention deadline of January 24, 2014, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed. On April 9, 2014, Staff filed a revised Exhibit A to the agreement. The Commission has jurisdiction over this matter pursuant to SDCL 49-34A, specifically, 49-34A-42, 49-34A-43 and 49-34A-55.

At its regularly scheduled meeting on April 15, 2014, the Commission considered this matter. Commission Staff requested approval of the agreement in order to update official electric service territory mapping data to accurately reflect current service territories served by the utilities. The Commission voted unanimously to approve the agreement. It is therefore

ORDERED, that the request for approval of the agreement to update mapping data to reflect current electric service territory boundaries shared by Lake Region Electric Association, Inc. and Codington-Clark Electric Cooperative, Inc. is hereby granted.
