On August 29, 2014, the South Dakota Public Utilities Commission (Commission) received a Petition of Otter Tail Power Company (Otter Tail) requesting Commission approval of an Environmental Quality Cost Recovery Rider tariff. The purpose of this request is to begin the recovery of Otter Tail's share of the costs of the required environmental retrofits to the Big Stone Plant located near Big Stone City, South Dakota and the Hoot Lake Plant, located near Fergus Falls, Minnesota. Otter Tail anticipates the rate impact of this request for both projects will be approximately 7.1 percent on average in the first year of the rider. Once the construction is complete in 2015, Otter Tail estimates the rate impact will be slightly less than 12 percent. Otter Tail proposes a November 1, 2014, effective date.

On September 4, 2014, the Commission electronically transmitted notice of the filing and the intervention deadline of September 19, 2014, to interested persons on the Commission's PUC Weekly Filings electronic listserv. On September 18, 2014, the Commission issued an Order Assessing Filing Fee assessing a fee up to the statutory limit of \$50,000 to cover the Commission's actual expenses incurred in processing this docket. On November 6, 2014, Otter Tail filed revised tariff pages reflecting a proposed effective date of December 1, 2014. On November 18, 2014, the Commission's staff ("Staff") filed a Staff Memorandum recommending Commission approval of the Environmental Quality Cost Recovery Rider tariff as filed.

ORDERED, that the aforementioned tariff sheets are approved with an effective date of December 1, 2014.
