On December 1, 2015, the South Dakota Public Utilities Commission (Commission) received a filing from Otter Tail Power Company (Otter Tail) for approval of changes to its updated Customer Information Brochure and tariff revisions to its Sample Forms. The tariff revisions were due to a change in contact information for Otter Tail. Otter Tail is requesting an effective date of January 1, 2016.

On December 3, 2015, the Commission electronically transmitted notice of the filing and the intervention deadline of December 18, 2015, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listsery. No petitions to intervene or comments were received. On December 11, 2015, Otter Tail filed its responses to Commission staff's data request. The revised tariff sheets are as follows:
