ORDER DISMISSING WITHOUT PREJUDICE AND CLOSING THE DOCKET

On December 22, 2016, the South Dakota Public Utilities Commission (Commission) received a filing from Trinity Point Limited Partnership (Trinity) requesting a variance of the individual metering requirement contained in ARSD 20:10:26. Trinity stated it plans to build a 48-unit multi-family housing structure designed to provide affordable housing to the community of Sioux Falls. On January 5, 2017, a Gas & Electric docket was created to take the place of the originally created electric docket.

On January 5, 2017, the Commission electronically transmitted notice of the filing and the intervention deadline of January 13, 2017, to interested individuals and entities. On January 5, 2017, Commission staff sent a copy of the individual metering variance request to MidAmerican Energy Company, Sioux Valley Energy Electric Cooperative, and Northern States Power Company in accordance with ARSD 20:10:26:06. On January 9, 2017, notice of the individual metering variance request was published in the Argus Leader in accordance with ARSD 20:10:26:06. On February 23, 2017, Commission staff filed a letter requesting that the docket be dismissed without prejudice and closed due to a lack of communication from Trinity. On February 27, 2017, Trinity filed a letter consenting to the dismissal as it no longer intended to master meter the project.

The Commission has jurisdiction in this matter pursuant to SDCL 49-34A-4 and ARSD 20:10:01:02.04 and 20:10:26.

At its regularly scheduled meeting on February 28, 2017, the Commission considered this matter. Finding that all the parties were in agreement that the docket may be dismissed without prejudice and closed, the Commission voted unanimously to dismiss the docket without prejudice and close the docket. It is therefore

ORDERED, that the docket is dismissed without prejudice and the docket is closed.
