On March 23, 2010, the South Dakota Public Utilities Commission (Commission) received a request for a waiver of 49 C.F.R. Section 192.285(a) (2) and 192.285(c) from Montana-Dakota Utilities Co. (MDU). On March 25, 2010, the Commission electronically transmitted notice of the filing and the intervention deadline of April 12, 2010, to interested individuals on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed. On April 30, 2010, the Commission issued an Order Granting Waiver. On August 9, 2017, MDU filed a letter requesting removal of the previously granted waiver stating the waiver is no longer necessary and is void by irrelevance due to a change in Pipeline Safety Regulations effective October 1, 2015.
