The Public Utilities Commission (Commission) annually provides certification to the Federal Communications Commission (FCC) that all federal high-cost support provided to eligible telecommunications carriers (ETCs) was used in the preceding calendar year and will be used in the coming calendar year only for the provision, maintenance, and upgrading of activities and services for which the support is intended. In its *USF/ICC Transformation Order*, the FCC set forth new annual reporting requirements for recipients of federal high-cost support. Some of these requirements are identical or similar to the Commission's ETC annual certification requirements. The FCC's reports are due by July 1, 2013. The Commission's requirements set a deadline of June 1, 2013.

At its March 26, 2013, meeting, the Commission considered whether it should consider revising or waiving any of its ETC requirements, including its June 1, 2013, deadline, in light of the FCC's new annual reporting requirements. After listening to comments from the South Dakota Telecommunications Association and Commission Staff, the Commission unanimously voted to open a docket to consider whether to revise or waive any of its ETC requirements regarding certifications to the FCC. The Commission set April 16, 2013, as the deadline for written comments. The Commission further found that it would make its decision at its April 23, 2013, meeting.

It is therefore

ORDERED, that a docket is opened to consider revisions or waivers to ETC certification requirements; and it is further
