ORDER GRANTING WAIVER AND CERTIFICATION

TC13-055

On June 24, 2013, the Public Utilities Commission (Commission) received a filing from Citizens Telecommunications Company of Minnesota, LLC (Company) requesting certification regarding its use of federal universal service support. The Company is also requesting the Commission grant a permanent waiver of the Commission's eligible telecommunications carrier (ETC) filing requirements pursuant to ARSD 20:10:32:56, on grounds that the reporting requirements in support of ETC certification are unduly burdensome and unnecessary. The purpose of this filing was to provide information constituting the Company's plan for the use of its federal universal service support and to otherwise verify that the Company will use all federal universal service provisions of 47 U.S.C. § 254. Pursuant to 47 C.F.R. § 54.314(a), in order for an ETC to receive support pursuant to the Federal Communications Commission's (FCC's) high-cost program, a state must file an annual certification with the Universal Service Administrative Company (USAC) and the FCC stating that all federal high-cost support provided to the ETC "was used in the preceding calendar year and will be used in the coming calendar year only for the provision, maintenance, and upgrading of facilities and services for which the support is intended."

On June 27, 2013, the Commission electronically transmitted notice of the filing and the intervention deadline of July 12, 2013, to interested individuals and entities. No parties sought intervention.

At its regularly scheduled meeting of October 22, 2013, the Commission considered this matter. The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31 and 47 U.S.C. § 254. The Commission unanimously voted to grant a one-year waiver pursuant to ARSD Section 20:10:32:56, finding that compliance with the certification requirements is unduly burdensome and unnecessary. The Commission also unanimously voted to approve the Company's request for certification. The Commission finds that the Company is eligible to receive federal support. The Commission finds that all federal high-cost support provided to the Company was used in the preceding calendar year and will be used in the coming calendar year only for the provision, maintenance, and upgrading of facilities and services for which the support is intended. It is therefore

ORDERED, that a one year waiver pursuant to ARSD Section 20:10:32:56 is hereby granted. It is further

ORDERED, that the Company is eligible to receive federal support as all federal high-cost support provided to the Company was used in the preceding calendar year and will be used in the coming calendar year only for the provision, maintenance, and upgrading of facilities and services for which the support is intended. It is further

ORDERED, that the Commission approves the Company's request for certification.
