On June 27, 2013, the South Dakota Public Utilities Commission (Commission) received a filing from Neutral Tandem-South Dakota, LLC. (Neutral Tandem). This filing implements the Federal Communications Commission's second phase of the intercarrier compensation restructuring, WC Docket No. 07-135 et al., to mirror interstate access rates and rate structures. Neutral Tandem requested an effective date of July 1, 2013. On July 10 and August 14, 2013, Neutral Tandem filed its responses to staff's data requests. The Commission voted unanimously to approve the requested revisions to Neutral Tandem's South Dakota Tariff No. 1, with the revisions as noted at the meeting. On September 5, 2013, revised tariff pages were filed. It is therefore

ORDERED, that the Commission approves the above-referenced revisions to Neutral Tandem's South Dakota Tariff No. 1 effective as of July 1, 2013.
