A Little History...

The arrival of the railroad in Dakota Territory caused great excitement. It would bring the much needed and appreciated transportation services to the remote plains. Along with the excitement quickly came disappointment: there was only one railroad – a monopoly – so it could charge whatever the travelers would pay. The settlers felt they were being cheated, so they took their complaints to the territorial government.

In 1882, the Territorial Legislature created an ad hoc committee to deal with railroad issues. Each year the committee became more burdened with the impact railroads had on Dakota Territory. Committee members felt there was no authority to enforce their decisions. In 1885, the Territorial Legislature established the Board of Railroad Commissioners. It's powers and duties were implemented in 1886.

The first session of the South Dakota Legislature (1889) expanded the Commission, increasing its powers and duties. The Board consisted of three members serving a two-year term, or at the pleasure of the Governor.

Since most grain facilities were adjacent to the railroads, regulation of grain warehouses was added to the Board's jurisdiction in 1890. In 1897, Commissioner offices became elected positions, accountable to the voting public. Each term of office was defined as a six-year term, with one Commission position elected each two years during the general election. Amendments in 1897 also gave the Commissioners the power to establish and enforce railroad rates.

In 1909, the Legislature abolished the Telephone Commission (created in 1907) and placed authority over telephone and telegraph operation with the Board of Railroad Commissioners.

In 1925, South Dakota became one of the first states to regulate for-hire motor carriers to assure public safety and reasonable rates. Freight rates, service territories and annual permits requiring adequate insurance became part of the Commission's responsibility. The Board was authorized to develop facts for presentation to the Interstate Commerce Commission and various courts. In 1937, the Commission was given authority to test and inspect heavy scales weighing one thousand pounds and over. Later, the scale authority was assigned to Commerce and Consumer Affairs.

In 1939, the name was changed to the Public Utilities Commission to reflect the wider range of responsibility.

In 1975, the State Legislature granted the Commission regulation over natural gas and electric utilities.

The Commission...

Consists of three members elected at-large. Commissioners each serve staggered, six-year terms. The current Public Utilities Commission is given legislative and statutory authority under Title 49 of the South Dakota Code.

What we do...

- ⇒ Assist the public in making wise utility choices, promote consumer utility interests through public policy, and resolve disputes between customers and their utilities. We also regulate the rates and service quality of investor-owned electric, natural gas, and telephone utilities.
- ⇒ Regulate territorial jurisdiction over all retail electric companies, including cooperatives, independents, and municipals.
- ⇒ Register interstate for-hire motor carriers.
- ⇒ Operate the South Dakota Do-Not-Call Registry.
- ⇒ Administer the state's one-call notification center, which locates underground facilities.
- ⇒ Operates the natural gas pipeline safety program.
- ⇒ License and inspect state public storage, state public grain warehouses, and grain dealers.
- ⇒ Provide information and resources to property owners interested in wind energy development.

~ Meet the Commissioners ~



Commissioner Gary Hanson was elected to the South Dakota Public Utilities Commission in November 2002. He currently serves as the Chairman of the Public Utilities Commission, and was selected as the South Dakota representative on the Organization of MISO States.

Gary Hanson is the fourth generation of his family to live and work in South Dakota. He is uniquely qualified to assure that issues before the PUC will be thoughtfully considered and thoroughly examined in a fair-minded and non-partisan manner. Gary was twice elected as Utilities Commissioner of Sioux Falls where he was responsible for the development and day-to-day activities of three municipal utilities.

Gary was also twice elected Mayor of Sioux Falls. As the City's chief executive and administrator, Gary oversaw 1,000 full and part-time employees and a budget of \$204 million. During Gary's service as a locally elected official, Sioux Falls grew by over 33,000 people.

Prior to local service, Gary served three terms as a State Senator, where he was Chairman of the Government Audit and Operations Committee, and Vice Chairman of the Senate Taxation Committee. He is a founder and past Chairman of the Lewis and Clark Rural Water System and active in South Dakota Water Development. Gary is a real estate broker and served as President of the Sioux Falls Board of Realtors.

Gary Hanson is active on several community and industry boards. He regularly shares his passion for athletics as a volunteer coach in a variety of youth sports, and enjoys hunting, fishing, and skydiving. Gary is also a licensed soccer coach, and a lifetime member of the Lion's Sight and Service Foundation.

Gary was honored as "Outstanding Young Citizen of South Dakota," Sioux Falls "City Father of the Year," and was inducted into the YMCA Tri-State Hall of Fame. He is a recipient of Habitat for Humanity's "Hat's Off" award, "Spirit of Downtown" Sioux Falls award, White Cane Safety award, Children's Care Hospitals' WINGS of Love award, was named as Distinguished Alumnus of Northern State University, and Multiple Sclerosis Society Chapter Mayor of the Year.



Commissioner Bob Sahr is a national leader in protecting consumers and developing telecommunications infrastructure in rural America.

In 2003, Bob led the effort to pass the South Dakota Do-Not-Call List. As a result, more than 212,000 South Dakota landline and cell phones are on the list with these households receiving far fewer telemarketing calls.

From 2002 to present, Bob has spearheaded a first of its kind in the nation program to build more cell phone towers. This has led to unprecedented investment in new cell tower sites in South Dakota with service coming to many rural communities for the first time.

Bob strongly supports policies to ensure South Dakotans continue to have access to state-of-the-art wire line communications. He was a tireless backer of the successful renomination of Commissioner Jonathan Adelstein to the Federal Communications Commission.

Commissioner Sahr is a grassroots advocate for wind power and renewable energy. Bob's efforts helped make South Dakota's first major wind farm a reality in rural Hyde County near Highmore, and his leadership and innovation have the state PUC recognized as a national leader in wind energy efforts.

In 2004, Bob traveled to China with the American Council of Young Political Leaders. He was one of ten young leaders in the nation selected for this prestigious international exchange program.

Bob grew up in Pierre where he was a member of the back-to-back state champion high school tennis team. He graduated with honors from the University of Colorado, Boulder in 1989 and then worked in sales and marketing for Michelin Tire Corporation. Bob earned his law degree from the University of Colorado School of Law where he was selected to Who's Who Among American Law Students.

Bob and his wife, Christine, welcomed their first child, Allison, in November 2002. He serves on the Pierre Municipal Library Board, is the chair for the local United Way fundraising drive, past president for Oahe Habitat for Humanity, and past board member for Countryside Hospice Board and the State Bar of South Dakota Bar Commission.



Commissioner Dustin "Dusty" Johnson was elected to the South Dakota Public Utilities Commission in November 2004. During his campaign, he emphasized the need for our state to have a proactive PUC dedicated to protecting consumers and to helping communities, businesses, and families acquire the telecommunications and energy infrastructure they need to succeed.

Prior to joining the PUC, Dusty served as the senior policy advisor to Governor Mike Rounds for economic development, transportation, corrections, and energy issues. He was a prime architect of the Governor's "2010 Initiative," a set of progressive and ambitious goals that provided the blueprint for South Dakota's economic future. He has also served as a management analyst for local governments in the Kansas City area and as a Truman Fellow for the U.S. Department of Agriculture in Washington, D.C.

Dusty is originally from Pierre, and received his B.A. in Political Science from the University of South Dakota and his Masters degree in Public Administration from the University of Kansas. In 1998 he was named a Harry S.

Truman Scholar.

Dusty and his wife Jacquelyn make their home in Mitchell and are expecting their first child in May.

- ☛ Do-Not-Call List registrations jumped to 212,398 landline and wireless phones.
- ☛ First of its kind in the nation wireless telecommunications initiative brought approximately 40 new cell phone towers (14 Verizon Wireless; 25-plus Cellular One) to the state with new service coming to many communities, including Parker, Howard, Arlington, Canton, Parkston, Rosholt, Blunt, White River, Mission, Rosebud, Burke, Fairfax, Hayes and Hermosa.
- ☛ Hosted a statewide South Dakota Wireless Conference in September in Spearfish with more than 130 attendees including keynote speaker Federal Communications Commission (FCC) Commissioner and Rapid City native, Jonathan Adelstein.
- ☛ Co-hosted FCC four-day visit to Rapid City and western South Dakota in May highlighting wireless broadband, Native American and consumer issues and featuring three FCC Commissioners: Chairman Michael Powell and Commissioners Jonathan Adelstein and Michael Copps.
- ☛ Hosted statewide Wind Summit in Sioux Falls in November with five major developers, utility companies and more than 100 participants.
- ☛ Held town meetings on wind power, cell phone service, high-speed internet and other utility issues.
- ☛ PUC's consumer protection department presented at several senior fraud prevention events.
- ☛ After two weeks of hearings, 19 rural local exchange carriers were granted relief from providing local number portability due to potential costs to consumers and projected low number of ports.
- ☛ Launched *Wind-E-News* email and print newsletter to communicate to landowners, local leaders and the public on wind energy issues.
- ☛ Debuted informational wind power video funded by U.S. Department of Energy grant.

HIGHLIGHTS continued

- ☛ Secured private donations and federal funding to more than double the number of sites for SDSU's wind power testing stations (the Wind Resource Assessment Network), one of the nation's leading wind measuring systems.
- ☛ Logged 2,368 consumer contacts in 2004 and informally answered thousands of other consumer questions at public events. Received petitions, emails and letters from several thousand South Dakotans wanting improved cell phone service.
- ☛ Issued two orders regarding rate increase requests by investor owned utilities, which saved their customers over \$1.16 million per year compared to what was requested by these utilities.
- ☛ Received \$150,000 in bond proceeds for the benefit of consumers who failed to receive pre-paid phone services from S&S Communications.
- ☛ Designated Western Wireless Corporation (which does business as Cellular One) as an eligible telecommunications carrier in most of the state, enabling them to receive federal dollars to construct and operate cellular towers and facilities.
- ☛ Granted East River Electric a siting permit to upgrade their existing 69 kV transmission line to 115 kV in the Sioux Falls area.
- ☛ Protected consumers' and ratepayers' interests in NorthWestern Corp. bankruptcy in a cost-effective manner.
- ☛ Uncovered a slamming scam that resulted in \$25,000 being paid directly to customers.

REGULATED UTILITY COMPANIES

The Commission has territory, complaint and quality of service authority over all natural gas, electric and telecommunication utilities operating within South Dakota. Certain utilities are exempt from the Commission's rate regulation. They include municipal, rural electric cooperatives and small, independent and cooperative telephone companies. The Commission retains its switched access rate making authority for all telecommunications companies providing local service, including small, independent and cooperative companies.
