

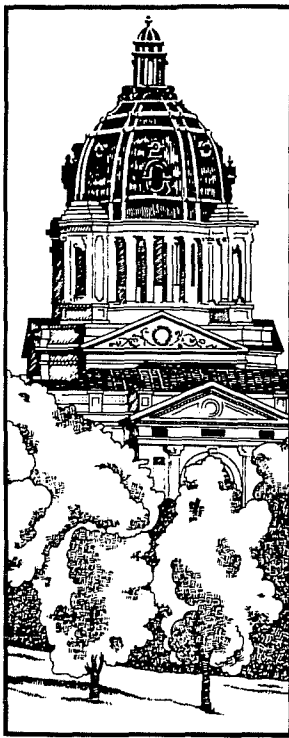

The Commissioners and Staff are available for discussion on any topic contained within the pages of this annual report.

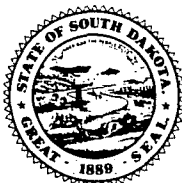

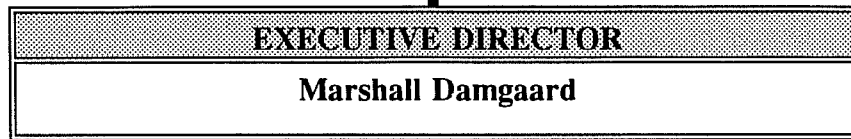
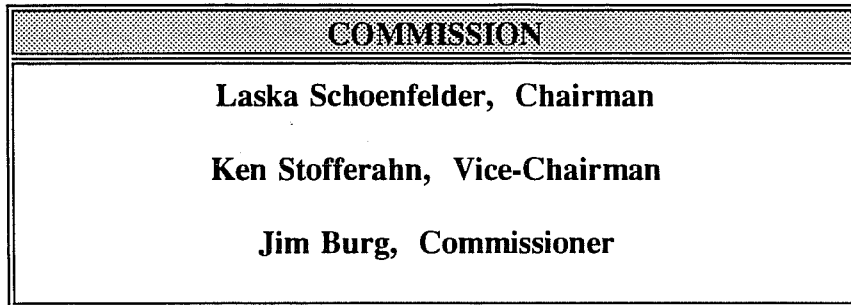

Organizational Chart



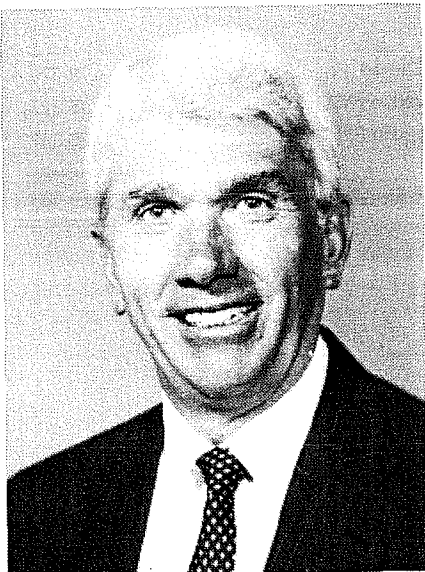

Commissioner Laska Schoenfelder (Republican) was elected to the Public Utilities Commission in 1988. Laska graduated from Lemmon High School and attended Dakota Wesleyan University in Mitchell. She was Davison County Register of Deeds from 1973-1982. Laska's work history with the State of South Dakota includes the Department of Commerce, the Bureau of Personnel, and the Office of Highway Safety. She is a member of the National Association of Regulatory Utility Commissioners and was appointed to NARUC's Committee on Communications in 1991. Laska counts the American Legion Auxiliary, V.F.W. Auxiliary, Cenkota, Republican Women's Federation, Farm Bureau, and the South Dakota State Historical Society as service memberships. She likes hunting, fishing, and horses. Laska and her husband, Mike, are the parents of five children. They are native South Dakotans and operate a farm near Mt. Vernon. Laska believes that the future of all South Dakotans will be enhanced if government and the private sector work together to bring the Information Super Highway to all rural and urban communities.



Commissioner Ken Stofferahn (Democrat) is serving his third term on the Public Utilities Commission. He was first elected to the PUC in 1978, after serving in the South Dakota House of Representatives in 1975-1976. Ken was a member of the West Central School Board in Humboldt from 1974-1978. He was president of the Board in 1974. He graduated from Humboldt High School in 1952 and South Dakota State University in 1957 with a B.S. in Agriculture. From 1957-1963 he served in the Air National Guard. Ken attended the National Judicial College in 1981, and the Annual Regulatory Studies Program at Michigan State University in 1981, 1982, and 1987. Currently, Ken is serving on the Committee on Electricity and a Subcommittee on Environment for the National Association of Regulatory Utility Commissioners. He has served as board member of the National Regulatory Institute at Ohio State University from 1985 through 1992, achieving a record tenure in that capacity. His service memberships include the Elks, Masons, Shrine, and Kiwanis. His hobbies include: "Kids, Cars, Old Dogs, and Watermelon Wine," with a little gardening and a record collection thrown in. Ken and his wife, Diane, have four children: Michael, Stacey, Stuart, and Steven. Ken, Diane and family are members of the Evangelical Lutheran Church of America. Ken has served in various capacities in the Lutheran Memorial Church in Pierre and has done special work with the Professional Preparations Committee with the South Dakota Synod.



Commissioner Jim Burg (Democrat) was elected to the Public Utilities Commission in 1986 and won his second term in November of 1992. He was elected to the South Dakota House of Representatives in 1974 and served five terms. He was elected to the South Dakota Senate in 1984 and served one term. He graduated from Lane High School in 1959 and South Dakota State University with a B.S. in Animal Science in 1963. He was Fieldman for the Federal Land Bank from 1964-1967. He returned to Wessington Springs and operated the family farm from 1967-1986. He served in the South Dakota National Guard from 1963-1990, retiring as a Lt. Colonel. Jim was Chairman of the Jerauld County Democrats from 1973-1974 and served on the Executive Board of the South Dakota Democratic Party. Past honors include Blue Key Honor Society, Jaycees Outstanding Young Farmer and Outstanding Young Religious Leader, Honorary State FFA Degree, Honorary Chapter Farmer (FFA), and Outstanding 4-H Alumnus. Jim is past board member of the South Dakota Chamber of Commerce and past board member and secretary-treasurer of the South Dakota Retailers Association. Other organizations include Knights of Columbus, Farm Bureau, and Farmers Union. He is Chairman of the Administration Committee for the National Association of Regulatory Utility Commissioners, member of the Board of Directors of the 4-H Foundation, and a past Board Member of SDSU Alumni Association. Jim and his wife, Bernice, have five children: Jeff, Cory, Julie, Casey, and Lisa. Dancing, hiking, and debating are Jim's favorite activities.

GOVERNOR APPOINTS TELEMEDICINE TASK FORCE

In August of 1993, Governor Walter Miller announced that he was appointing a 13-member task force to look into the possibility of using televised communications to improve health care in South Dakota. The Governor has asked PUC Chairman Laska Schoenfelder to help provide technical support for that endeavor.

HOME OF THE FUTURE BEING BUILT

The SDPUC is a co-sponsor of the E-2000 Energy Efficient Home of the Future. The house is being constructed by Clay-Union Electric Cooperative in Vermillion, South Dakota, using the latest and greatest energy-saving technology available. The home is a demonstration project intended to educate contractors, consumers, and trade school students and teachers. When the home is sold, the profit will be given to the Vermillion Development Corporation. The Grand Opening will be February 21, 1994. Tours of the home can be arranged by calling 1-800-696-2832.

COMMISSIONERS AND STAFF BLITZ YANKTON-VERMILLION

During two days in November of 1993, the three Commissioners and seven Staff spoke to over 30 groups in the Yankton-Vermillion area of South Dakota. The groups included senior citizens, business and community leaders, and elementary, secondary, and college students. Topics ranged from "What Is The PUC, and What Does It Do?" to "The Global Village; How Telecommunications Technology Is Shrinking Our World."

(MORE)GAS IN PIERRE

The South Dakota Intrastate Pipeline Company (SDIPC) has constructed a natural gas pipeline from Northern Border's Compressor Station #9 in northeastern South Dakota to the capital city of Pierre. Montana-Dakota Utilities (MDU) is the local distribution company now providing retail service. During the construction of the distribution system in Pierre, several local residents voiced complaints about the post-construction landscaping. Complaints have subsequently subsided, perhaps because of improved landscaping, MDU's public relations efforts, or several blizzards which have covered the evidence. In December of 1993 MDU bored under the Missouri River in Pierre, extending installation of the pipeline to Fort Pierre.

RATE STABILITY PLAN FILED, WITHDRAWN; ROSEBUD IN, OUT; POWER PLANT BEING CONSTRUCTED

In October of 1992, Black Hills Corporation (BHC) filed for a rate stability plan which would have increased BHC's electric rates. The application was due to BHC's plan to construct an 80 MW coal fired power plant at Wyodak, Wyoming. Rosebud Enterprises of Boise, ID, an independent power producer, filed to intervene. Rosebud sought to supply BHC's energy needs by building a 40 MW petroleum coke generating plant near Edgemont, SD. Citing favorable economic factors, BHC subsequently withdrew its rate stability plan, and in April of 1993, the Commission ruled that Rosebud's proposal was not timely. BHC moved ahead with its construction plans and indicated that it would file a related rate case in 1995.

MERGER MANIA CONTINUES

The Commission's FY91 report noted that by the final day of FY91, four purchases and five mergers involving twelve grain facilities had been completed. Since that time an additional 72 facilities have been involved in some type of ownership change. During 1993 24 facilities underwent ownership changes. Although industry analysts have been predicting declines in the number of grain companies for years, the accelerated pace of the decline over the last few years has definitely opened some eyes.

The reasons for the problems in the industry today remain the same. Government programs have taken millions of acres of farmland out of production and the government is not storing grain for long periods of time as it has in the past. Foreign competition has softened international markets and transportation costs continue to rise, and in South Dakota at least, mother nature seems unwilling to yield to moderation. Thus country elevators continue to face an uncertain future.

ABERDEEN JOINS THE TELECOMMUNICATIONS REVOLUTION

In June of 1993, Commissioners and Staff hosted a public input meeting in Aberdeen to hear concerns from local business leaders about the inadequacy of their telecommunications service. U S WEST and AT&T subsequently volunteered to upgrade facilities in Aberdeen by March 1, 1994. In November of 1993, Hospitality Franchise Systems announced that it was bringing a Howard Johnson reservation center to Aberdeen, initially creating 150 jobs.

ELECTRO-MAGNETIC FIELD (EMF) DOCKET OPENED; COMMENTS POURING IN

In February of 1993, the SDPUC voted to open an investigation into the effects of electric and magnetic fields. Comments have been sought from consumers, companies, and other parties of interest. Over 75 parties have filed comments. Commission Staff have done a variety of EMF measurements and have examined numerous national and internal studies. Over the next few years the US Department of Energy will spend \$60 million to study EMF and any related effects. No cause-effect relationships have been proven to exist. The Commission is planning a conference on EMF to be held in the Spring of 1994 in Brookings.

COMMISSION DEBATES ASSIGNMENT OF N11 CODES

In February of 1993, Infodial a division of Marketlink, filed an application for the assignment of N11 Codes. In August of 1993, the commission denied Infodial's application but ordered that a new docket be opened for the purpose of developing procedures for the review and evaluation of request for the assignment of N11 codes.

COMMISSION TOURS NORTHWESTERN SOUTH DAKOTA

In September of 1993, the three Commissioners and several Staff spent two long days touring the northwest corner of the state. Visits were made to the Cheyenne River Sioux Tribe Telephone Authority and the Presentation College satellite nursing school in Eagle Butte, Grand Electric Coop and West River Coop Telephone in Bison, and the Koch Oil Fields near the Cave Hills, just east of the Montana border and just south of the North Dakota border.

COMMISSION PURSUES ILLEGAL GRAIN BUYERS

During 1993 the Commission investigated several complaints concerning unlicensed grain buyers. While the majority of these investigations resulted in informal resolution, two required formal Commission action. In both cases grain buyers purchased oats, 11,000 bushels in total, and failed to pay for it. This is the most common way the Commission discovers unlicensed grain dealers. Under South Dakota Law, each purchase of grain without a license is a Class 2 misdemeanor. In addition, the Commission may assess a civil fine against an unlicensed dealer in the amount of one hundred dollars for each purchase up to a maximum fine of five thousand dollars.

Complaints were filed against both perpetrators in circuit court in Pierre. Circuit Judge Steven Zinter issued orders barring both from doing business in South Dakota until they obtain the necessary licenses. The Commission imposed the maximum fines allowable under the law. Several newspapers and trade publications throughout the Midwest printed stories regarding the Commission's enforcement actions. Since the articles ran, no additional complaints have been received regarding either of the grain dealers fined.

TELECOMMUNICATIONS ACCESS RATE CASES GRINDING INEXORABLY TOWARD HEARING

With a group of over 30 separate dockets, the SDPUC is now working toward the determination of switched access rates for every local exchange telephone company in South Dakota. Most dockets resulted in settlement agreements.

STMP

In December 1993, new regulations concerning REA's

telephone loan program were received by the Commission. Under the new rules, a state is eligible until December 20, 1994 to develop a proposed state telecommunications modernization plan (STMP) and deliver it to REA. The plan must set service requirements and objectives for improving the public switched network. It is expected that the Commission will take action on this issue in early 1994.

MIDWEST GAS ACQUIRES MINNEGASCO PROPERTIES

On September 1, 1993, Midwest Gas acquired Minnegasco's natural gas distribution properties and associated assets in South Dakota. The acquisition was part of a transaction whereby Midwest Gas agreed to exchange its Minnesota utility property for Minnegasco's South Dakota utility property plus \$38 million. As required by ARSD 20:10:13:29, all rates charged by Minnegasco were adopted by Midwest Gas.

PIPELINE SAFETY: DOES THE STATE WANT TO GET INVOLVED?

The SDPUC plans to introduce into the 1994 South Dakota Legislature a bill giving the Commission responsibility over the safety inspection of intrastate natural gas pipelines. South Dakota is currently one of only four states which do not regulate intrastate pipeline safety, allowing the federal government to handle all aspects of the program. A similar bill, which also covered hazardous liquids, was introduced by several legislators into the 1992 Session; it passed the Senate but was bushwhacked in the House. The Commission's bill probably faces an uphill battle.

COMMISSION INVESTIGATES EXTENDED AREA SERVICE

At its regularly scheduled February 9, 1993 meeting, the Commission voted to open an investigation into Extended Area

Service (EAS). EAS changes the way customers are billed when calling from one exchange to another. EAS is usually paid by all exchange customers as an addition to the monthly basic rate instead of having each call billed as a toll or long distance call. EAS charges are mandatory within the exchange where EAS was granted even though not all customers call the neighboring exchange.

A questionnaire was mailed April 28, 1993 to the local exchange companies, the interexchange carriers, cellular companies, radio common carriers, the coordinator of all South Dakota Gold Communities and to interested individuals. Responses were received from 10 local exchange companies (including U S WEST), two interexchange carriers (AT&T and U S WEST), one Gold Community (Ipswich), one cellular company (Cellular, Inc.), South Dakota Independent Telephone Coalition, Inc. and one interested individual (a health care facility in the northern Black Hills).

The Commission fully regulates local exchange service which includes EAS arrangements. Long distance service is classified as fully competitive, i.e., no Commission oversight. In order to provide new EAS arrangements the Commission will have to reclassify part of a fully competitive toll market into a fully regulated EAS environment.

TERRITORIAL QUESTIONS RETURN TO THE FRONT BURNER

During 1993, the Commission received several consumer and company complaints and petitions for declaratory rulings concerning electric service territories. Several cases arose because Sioux Falls continues to expand, and the territorial boundaries established two decades ago do not seem as crystal clear or logical today as they must have then.

ARRIVALS AND DEPARTURES

On May 14, 1993, **Stephanie Stocking** was named the Commission's Consumer Representative, replacing Kathy Lucas, who resigned on May 12, 1993. Stephanie has been with the Commission since July, 1991 as a legal secretary. **Terri Lesmcister** began work as an administrative assistant in the Transportation/Warehouse Division on May 24, 1993. She replaced Mary Sieck, who left after 18 years with the Commission. Terri is a 1992 graduate of Northern State University with a major in Administrative Systems. **Rebecca Zebroski** started with the Commission as a legal secretary on June 7, 1993. She is a 1990 graduate of Lake Area Vocational Technical Institute in Watertown, majoring in Modern Office Occupations. Two utility analysts were also hired during 1993. **Becky Foote** started July 6. She graduated from the University of Minnesota-Morris, with majors in business and economics and a minor in speech communication. At UM-M she worked as an accounting teaching assistant and a business/economics research assistant. **Paulette Gates, CPA**, joined the Commission July 15. She worked in public accounting in Denver for two years after graduating from Black Hills State University.

"CALL THE BARN" CONTROVERSY RESOLVED WITH DEMOCRACY AND COMMON SENSE

In October of 1993, angry farmers contacted the SDPUC expressing disgust over the loss of their "call the barn" service, which was actually an unintentional by-product of obsolescent analog switching. When U S WEST Communications (USWC) upgraded switches in rural areas, farmers were no longer able to call

between their houses and farm buildings. Following a public input meeting in Castlewood, USWC announced that with additional investment the service would again be available, first in Castlewood and then in other rural areas.

ICC ADOPTS NEW RULES FOR INTERSTATE MOTOR CARRIER REGISTRATION

In 1993, as part of the Intermodal Surface Transportation Efficiency Act of 1991 (ISTEA), the Interstate Commerce Commission (ICC) established the Single State Registration System (SSRS). The SSRS will replace the former bingo stamp program. Under the new system, interstate motor carriers will register their ICC operating authority and provide proof of insurance with only their base registration state. That state will then be responsible for collecting fees for all participating states in which the carrier intends to operate. In place of the bingo stamps currently being used, the registration state will issue one receipt to the motor carrier which will specify the carrier's name, address, ICC number, a list of states for which the carrier has submitted fees, and the number of trucks he/she has registered in each state.

The new system will substantially reduce the administrative burden born by the industry under the old system and dictates uniformity in administration of the program throughout the states.

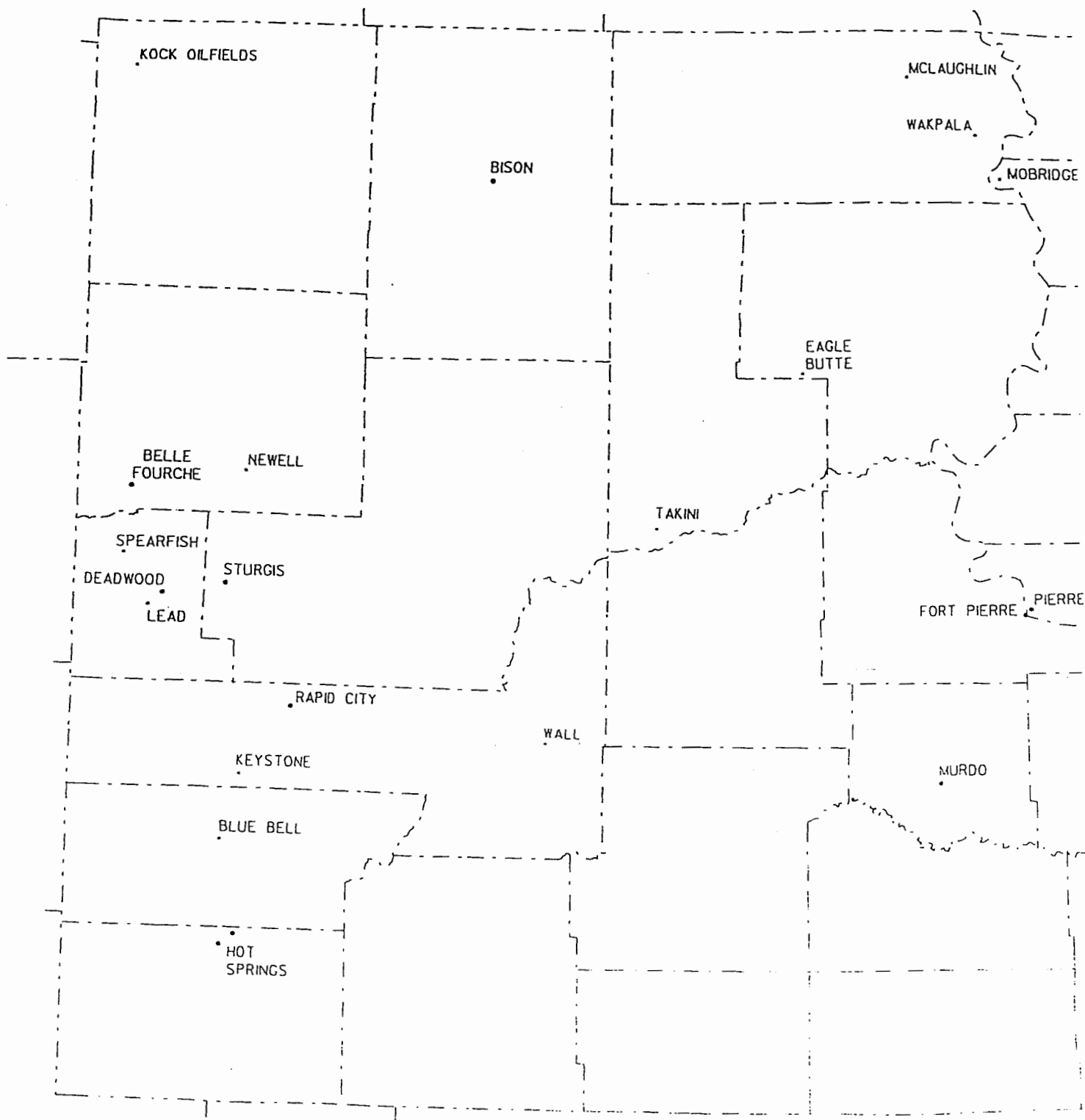
The primary concern among the states is the opportunity provided under the new system for under-reporting of fleet sizes with little opportunity for the states to economically bring the violators to justice and maintain effective roadside enforcement.

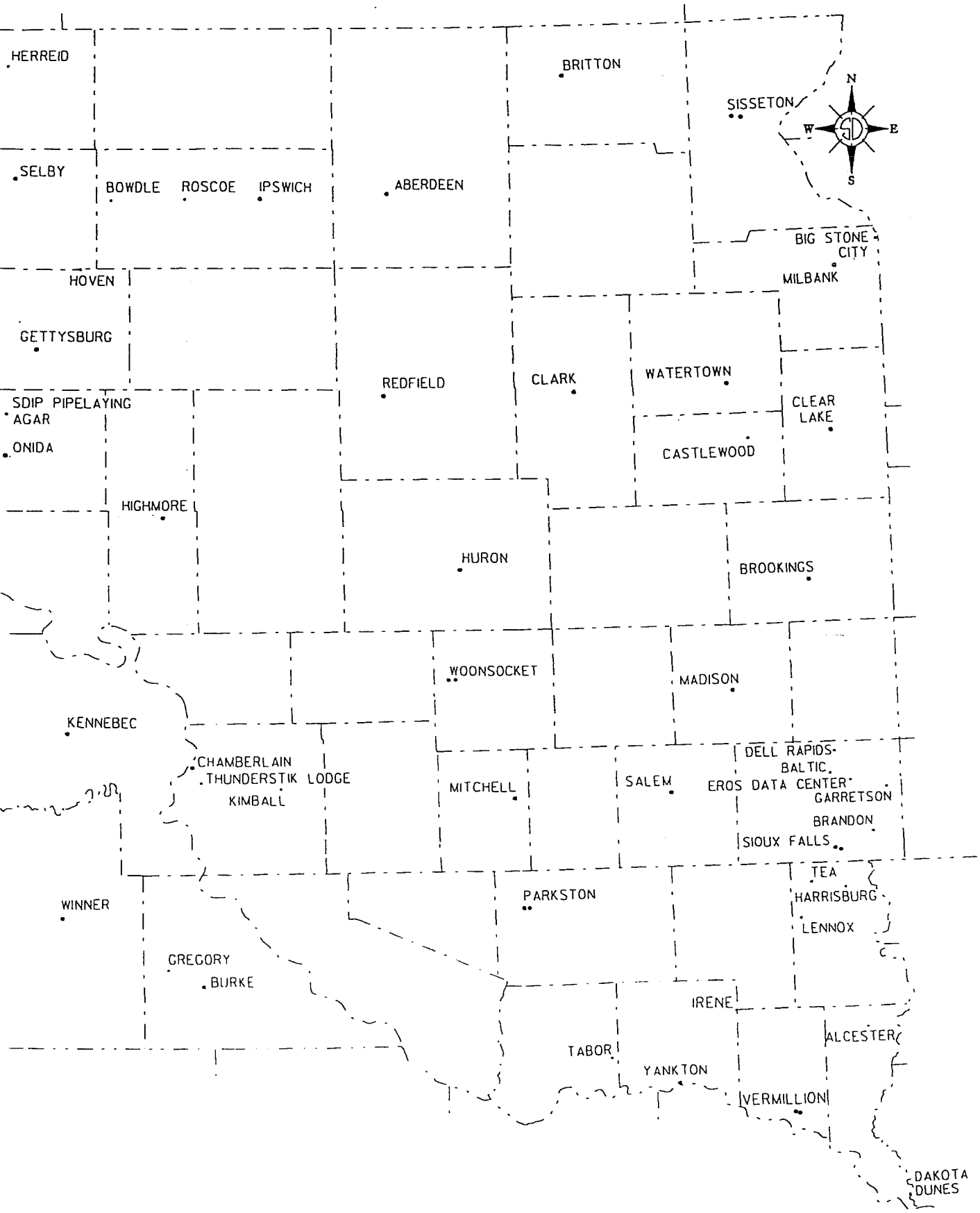

This chart illustrates the dramatic increase in work load due to the transition from monopolistic to competitive markets.

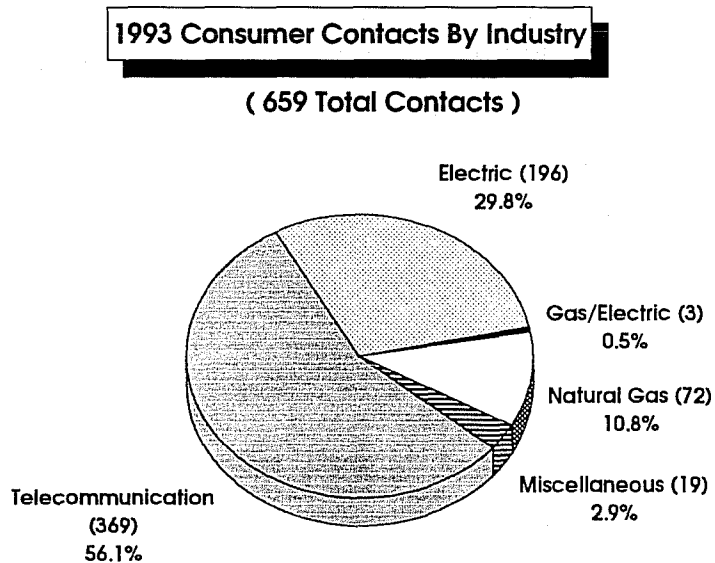

1993 CUSTOMER COMPLAINT ACTIVITIES

The Consumer Complaint Division of the South Dakota Public Utilities Commission investigates complaints and responds to contacts from the public regarding utility-related matters. Utility customers can contact the PUC by mail or through the toll-free Consumer Helpline (1-800-332-1782), the regular business number (605-773-3201), or through the Telecommunication Device for the Deaf telephone number (1-800-877-1113). Customers can also visit the PUC's office at the State Capitol Building in Pierre to discuss utility-related concerns. The Consumer Representative is available Monday through Friday, from 8:00 a.m. - 5:00 p.m. to respond to the public and investigate utility-related problems.

Figure 1 illustrates the 659 customer contacts received by the Consumer Complaint Division of the PUC in 1993. (This figure does NOT include contacts received by Commissioners or Commission Staff not directly working with consumer complaints; booth visitors; public input hearing attendants; or any transportation or warehouse contacts.) Figure 1 breaks down the different industries: Telecommunications, Natural Gas, Electric, Gas/Electric, and Miscellaneous.



As **Figure 1** demonstrates, electric and telephone utilities continue to generate the majority of informal complaints received by the Commission. This is generally to be expected since these utilities account for the greatest number of customers, the largest plant investment, and the most frequent regulatory activities. Each of these types of utilities has recorded increases in the number of informal complaints processed. In the case of electric utilities, more consumers are experiencing difficulties in paying their bills and are seeking assistance in making payment or other arrangements with the utility. Deregulation and interexchange competition in the telephone industry have caused increased confusion regarding the billing of toll calls. Also, consumers are expressing concern regarding increased telemarketing activity and pay-per-call services.

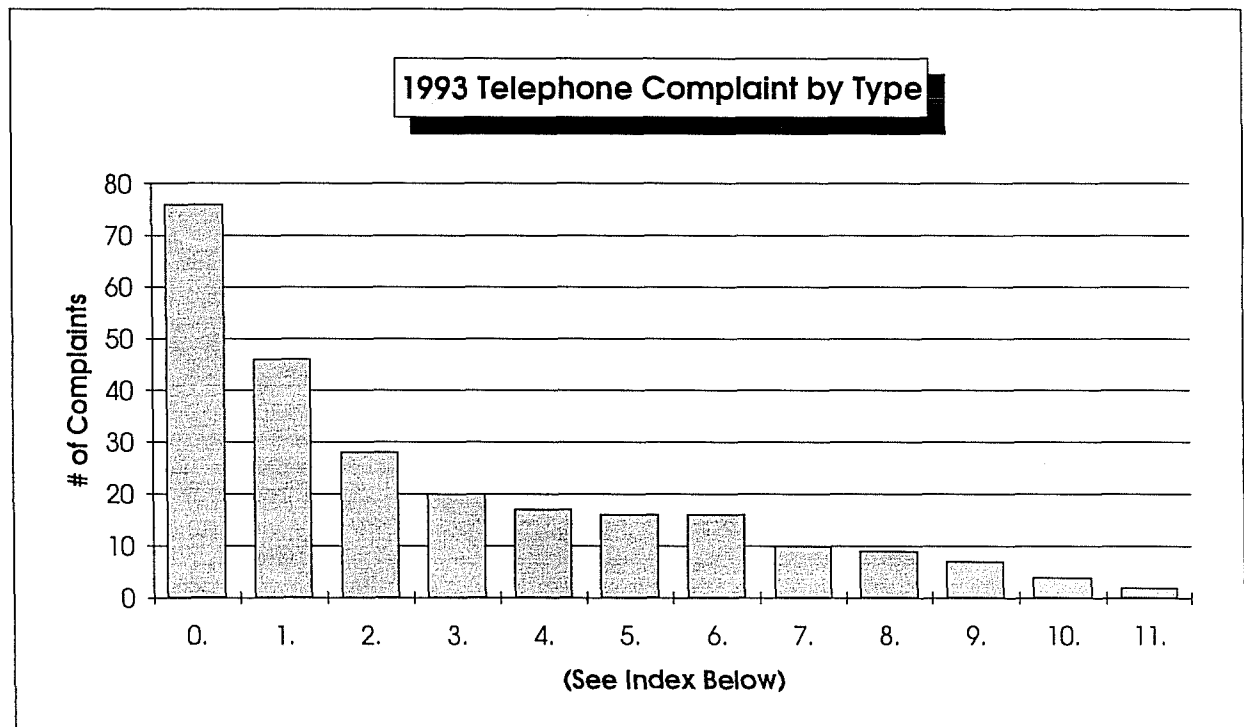
The Commission's Consumer Outreach efforts communicated with over 30,000 individuals at events such as the state fair, home shows, general information meetings, workshops, and various seminars.

Customer contacts are divided into two categories - customer **complaints** and **inquiries**.

CUSTOMER COMPLAINTS

Complaints are customer contacts received by the Commission that require investigation and communication with the involved utility company. These contacts do not necessarily conclude with a determination of error or violation of the PUC's rules on the part of the involved utility company, but do indicate that the company was initially unable to satisfy a customer. The customer then contacts the PUC to get help resolving the problem. Complaint calls are more than just a question. Typically, several telephone conversations may occur between the parties before a complaint can be resolved. The PUC must receive, verify, and analyze all relevant information and occasionally conduct a field investigation before making a determination. In 1993, a total of 464 complaints were handled by the Commission. Of that total, 251 were telecommunications complaints.

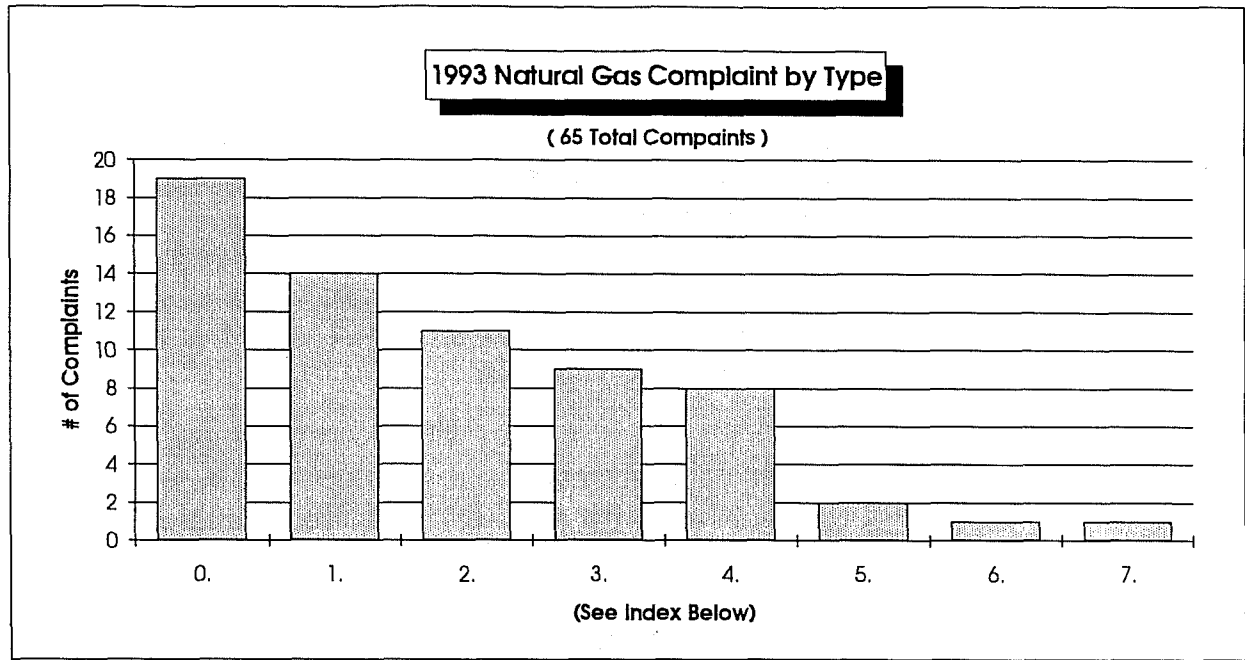

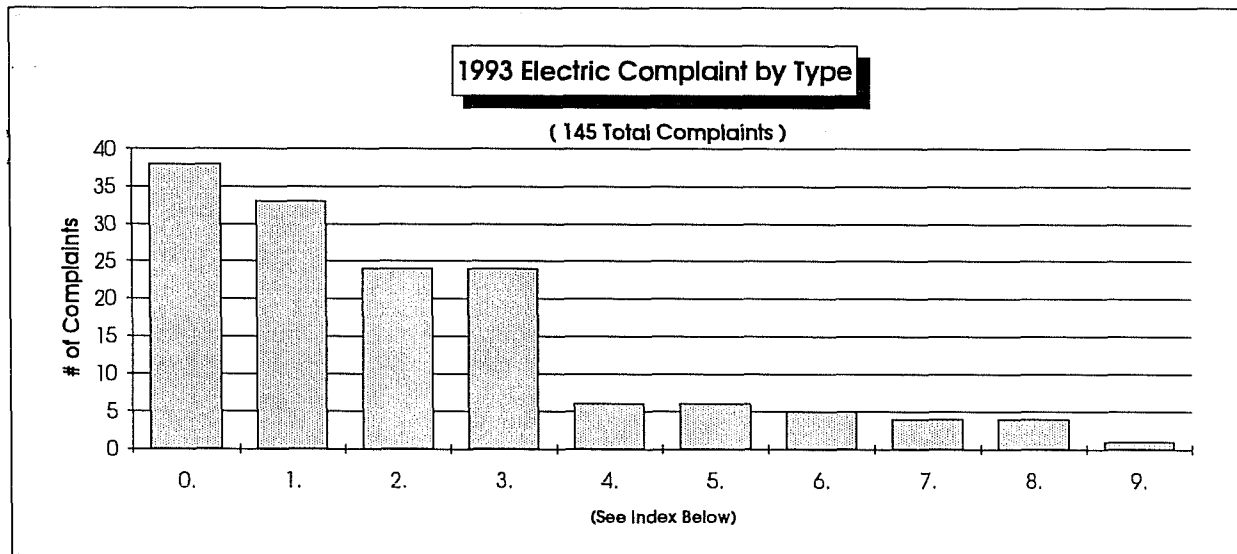

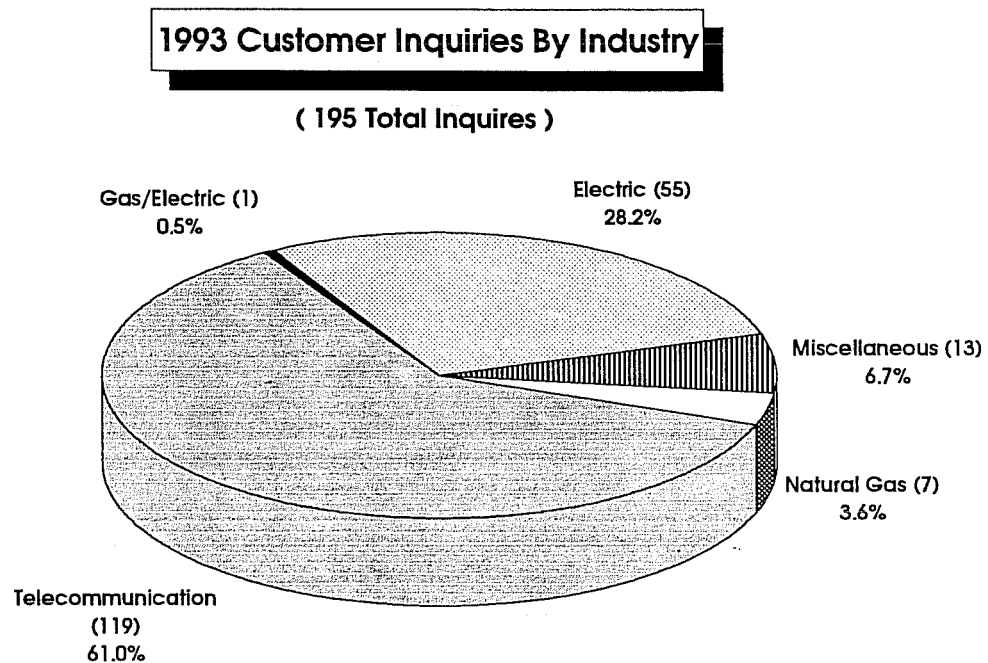

CUSTOMER INQUIRIES

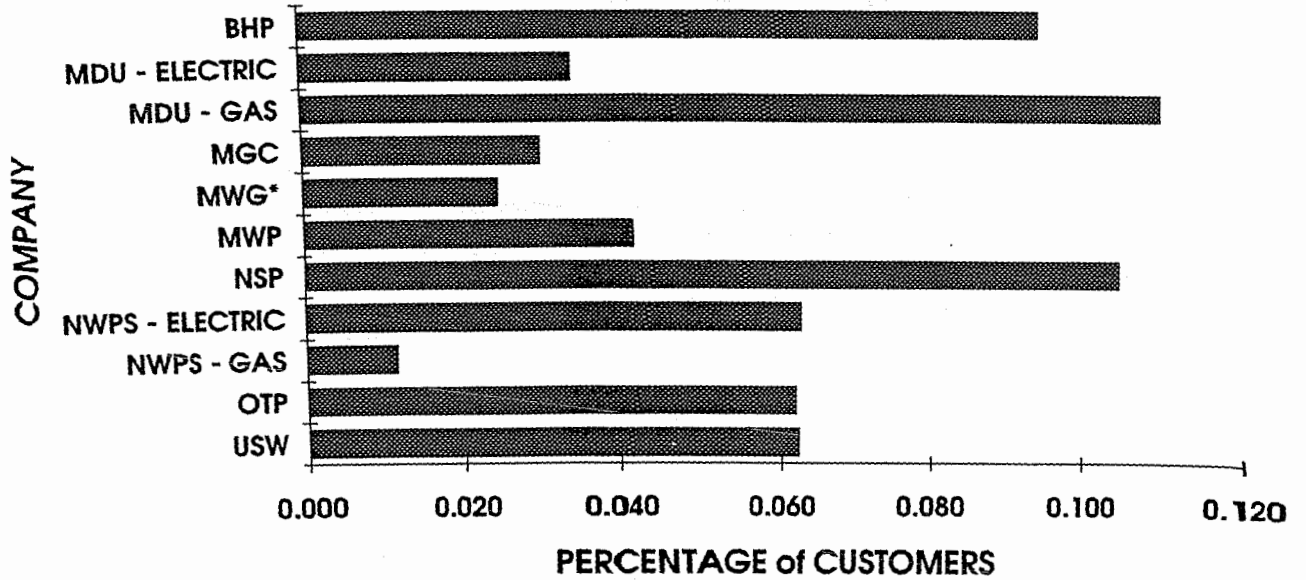
Inquiries are contacts typically by telephone, in which questions were answered or opinions were expressed. The inquiries were calls for information, usually questions regarding utility practices or commission rules, and other utility-related issues. Questions included a wide range of topics, including general company policies, regulatory policies, rates, bills, regulatory-related law, nonregulated companies and Commission action or decisions. Inquiries are handled by the PUC without the need to contact the involved utility company. In 1993, a total of 195 inquiries were handled by the PUC.

Figure 5 illustrates the number of customer inquiries the PUC received about telephone, electric, natural gas, gas/electric, and miscellaneous utilities in 1993:

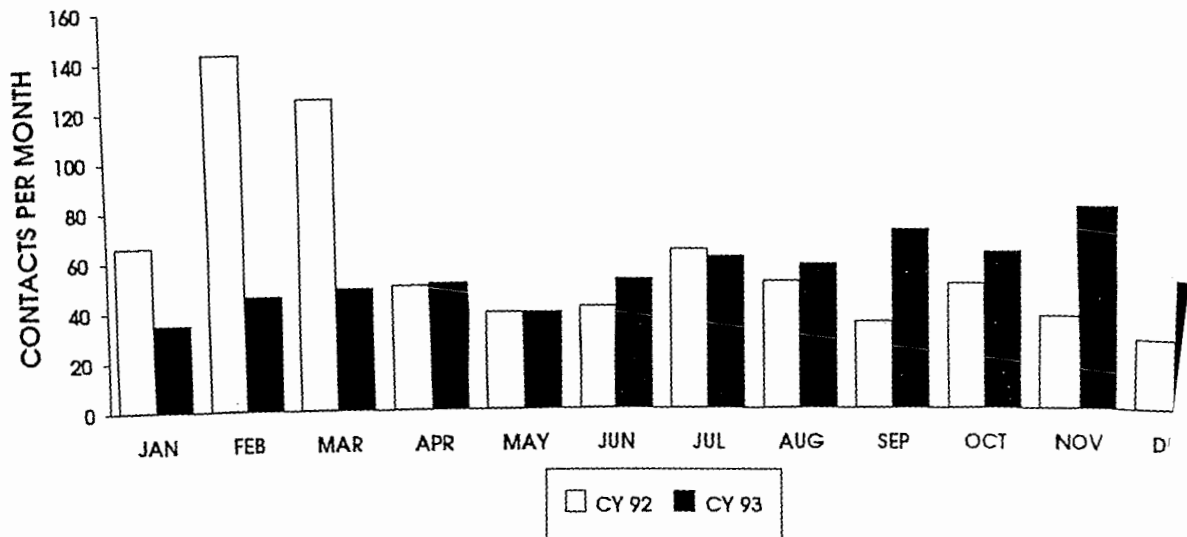
SOUTH DAKOTA INVESTOR-OWNED UTILITIES Customer Contact Percentages Per Customer Base

1993 LEGISLATIVE ACTION

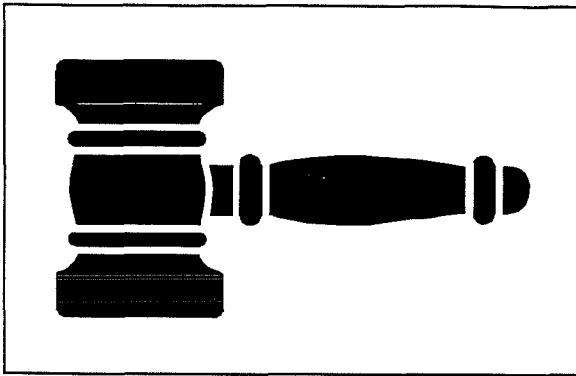
SB 92 Repealed SDCL 49-28-40.1 and amended 49-28-40.2 to allow motor carriers 48 hours to produce a copy of their class A or class B permit to a law enforcement official. It had unanimous approval in the Senate and was passed in the House, 67-2. It was signed into law by the Governor on March 3, 1993.

SB 288 Abolished the Governor's office of energy policy and transferred its functions to the Public Utilities Commission. It passed in the Senate on February 23, 1993, 20-15. It was tabled in the House committee.

SB 300 Directed the Public Utilities Commission to prepare a statewide 911 plan and directed LRC to conduct an interim study. It passed in the Senate on February 18, 1993, 19-14. It was tabled in the House committee.

HB 1177 Proposed to minimize the possibility of cross-subsidization of nonutility business by a rate-regulated public utility. The bill was deferred to the 41st day in the House committee.

HB 1205 Established a one call system to notify utilities of excavation activities near the underground facility and to provide for certain civil penalties for failure to notify. As amended by the House Transportation committee it passed in the Senate on February 26, 1993, 35-0; and it passed in the House on February 18, 1993, 61-9. It was signed into law by the Governor on March 5, 1993.



1993 COURT APPEAL CASES

COMMISSION HAS A RELATIVELY QUIET YEAR BEFORE THE COURTS

GRAIN DEALERS

In The Matter of the Public Utilities Commission v. Dorothy Hodges d/b/a Hodges Grain Company, Civ. No. 93-86

On March 10, 1993, the Commission filed with the Sixth Judicial Circuit Court a copy of the Summons and Complaint which was served by mail that day upon Dorothy Hodges the owner of Hodges Grain Company, St. Joseph, Missouri. The Complaint alleged that on five occasions in September and November of 1992, Hodges Grain Company transacted business in South Dakota as a grain dealer without a license by contracting to purchase oats for resale from the Lake Norden Farmers Elevator and the Osceola Farmers Elevator of Iroquois.

Dorothy Hodges did not respond to the service by mail and therefore, on April 30, 1993, the Commission sought personal service of the Summons and Complaint through the sheriff's office of Buchanan County, Missouri. Dorothy Hodges was served on the 4th of May, 1993.

The period for the filing of an Answer to the Complaint expired without a response and on July 12, 1993, the Commission filed a motion with the Court for a Default Judgement. Circuit Judge Steven L. Zinter signed the requested judgment on July 13, 1993. Under the terms of the Default Judgment, the defendant was:

- 1.) Enjoined from transacting business as a grain dealer in South Dakota until properly licensed and bonded to do so;
- 2.) Fined a civil penalty of \$500.00 (\$100.00 for each transaction) and
- 3.) Assessed the Commission's cost of obtaining personal service.

As of December 31, 1993 the Default Judgment remains in effect.

In the Matter of the Public Utilities Commission v. Wendell Kleen a.k.a. Arthur Wendell Kleen d/b/a Mid States Feed Grain Trust and d/b/a Central Commodity, Civ. No. 93-297

On August 12, 1993, the Commission mailed a Summons and Complaint to the sheriff's department of Vernon County, Missouri, to be served upon Wendell Kleen of Nevada, Missouri. Copies of the Summons and Complaint were filed with the Sixth Judicial Circuit Court the same day. The Complaint alleged that the defendant, doing business as

Mid State Feed Grain Trust and as Central Commodity, had transacted business in South Dakota as a grain dealer without a license on three occasions in January and April of 1993, by purchasing oats for resale from Johnson Feed, Inc., of Fairview and the Farmers Cooperative Elevator of Avon.

The defendant was served on August 18, 1993. After the time for filing an Answer to the Complaint expired without a written response from the defendant, the Commission filed a motion for a Default Judgment on September 24, 1993. Circuit Judge Steven L. Zinter entered the requested judgement on September 27, 1993. The Default Judgment ordered that:

- 1.) The defendant be permanently enjoined from transacting business as a grain dealer in South Dakota until licensed and bonded to do so; and
- 2.) The defendant pay civil penalties of \$300.00 (\$100.00 for each transaction).

As of December 31, 1993, the injunction remains in effect.

TELECOMMUNICATIONS

In the Matter of the Proposed Brookings to Sioux Falls Joint Lightwave Toll Facility in South Dakota, F-3699; In the Matter of the Application of South Dakota Network, Inc. and SDCEA, Inc., for Permission to Construct Centralized Equal Access Facilities, F-3860; In the Matter of the Application of Brookings Municipal Telephone, Interstate Telecommunication Cooperative, Inc., McCook Cooperative Telephone Company and Sioux Valley Telephone Company to Construct Noncompetitive Telecommunications Facilities, F-3866

At the time of the Commission's 1992 Annual Report the above cases were consolidated on appeal before the Supreme Court. The Supreme Court rendered its decision on August 11, 1993. The Supreme Court affirmed the Commission's decision, in part, reversed, in part, and remanded the case to the Hughes County Circuit Court for further proceedings. The Supreme Court determined that the Commission exceeded its authority by granting SDN a monopoly over terminating switched access destined for SDN member local exchanges. The Court further decided that this portion of the Commission's decision constituted an unlawful taking of USWC's property (inverse condemnation) for which damages may be awarded, if any exist. However, the Court did uphold the Commission's authority to compel access by requiring all interexchange carriers to connect with SDN's switch in Sioux Falls. On remand the Circuit Court, by order dated November 30, 1993, directed the Commission to amend its final orders in the above three dockets consistent with the Supreme Court's decision. The Commission is in the process of amending its orders consistent with the Supreme and Circuit Court decisions.

In the matter of the Application of Brookings Telephone Co. to Revise its Local Exchange Franchise Service Territory, TC91-107

At the time of the Commission's 1992 Annual Report this matter was being briefed before the Supreme Court. The appeal has now been briefed and the parties are awaiting a decision by the Supreme Court.

INTRODUCTION TO UTILITY PAGES

While only ten companies in South Dakota are rate-of-return regulated by the Public Utilities Commission (Commission), their combined intrastate gross revenue totaled more than 450 million dollars in 1993. Two of the companies under the Commission's jurisdiction provide both natural gas and electric service: Montana-Dakota Utilities and Northwestern Public Service. Four provide only electric service: Black Hills Power & Light, Midwest Power, Northern States Power, and Otter Tail Power. Midwest Gas provides only natural gas service. South Dakota Intrastate Pipeline Company provides only natural gas pipeline service. U S West Communications is the sole telecommunications company rate-regulated by the Commission. Through the gross receipts tax and the regulatory assessment fee, these rate-regulated utilities help support the operation of the Fixed Utilities Division of the Commission. For the 1993 Public Utilities Commission Annual Report, all ten of these utilities were offered a one-page opportunity to present, in their own words, who they are, what they have done, and what they will do in the future.

U S WEST Communications is in the "connections" business. We connect people to people via local telephone service, intraLATA long distance and connections to other telecommunications companies. We connect people on the move, with call forwarding, voice messaging and fax storage and retrieval. We connect people to telephone listings through the White Pages, and through our directory assistance service.

Looking ahead, we are building connections with tomorrow through major investments in technology. These "electronic" highways have replaced "one-lane" roads that characterized the copper wire routes used exclusively until the mid-1980s. The tiny strands of glass carry calls on beams of light and allow customers to send much more information, much faster, with more accuracy.

Since 1990, U S WEST has upgraded the switching equipment in 59 telephone exchanges, as part of a service modernization agreement with the Public Utilities Commission. Today more than 98 percent of our customers are served by computerized call-switching systems, which provide faster service, require less maintenance, and enable us to offer optional call management features like call forwarding, call waiting, three-way calling and speed calling.

Ten exchanges are getting digital switching systems in 1994. By the end of the year, computerized call-switching and the optional features will be available to all of our South Dakota customers.

As a company with more than 220,000 customers in South Dakota, U S WEST has a strong financial connection in the communities we serve. Last year we paid over \$7.3 million in property taxes; we paid over \$317,000 in city and state use tax; we collected over \$6.7 million in city and state sales tax for the State of South Dakota; we paid nearly \$11 million in federal income tax; and we contributed more than \$550,000 through the U S WEST Foundation and direct gifts to support economic development, education, charitable and cultural programs.

Black Hills Power and Light Company was incorporated under the laws of South Dakota in 1941. In 1986 the Company changed its name to Black Hills Corporation and now operates its investor-owned electric utility operations under the assumed name of Black Hills Power and Light Company. In addition, the company has diversified into coal mining through Wyodak Resources Development Corp. and oil and gas production through Western Production Company.

Black Hills Power is engaged in the generation, purchase, transmission, distribution, and sale of electric power and energy in 11 counties in western South Dakota, northeastern Wyoming, and southeastern Montana. The territory served by Black Hills Power includes 20 incorporated communities and various unincorporated and rural areas with a population estimated at 165,000. The largest community serviced is Rapid City, South Dakota, with a population, including environs, estimated at 75,000. Our service area economy continues to be stable, primarily due to its diversity.

ELECTRIC POWER SUPPLY

Black Hills Power has experienced no difficulty in serving the increasing demand of our customers for electric power and energy. Black Hills Power meets this demand, which is approaching 300 MW, primarily through owned generation and long-term and short-term power purchases from other utilities. In August of 1993, Black Hills Power broke ground on an 80 MW coal-fired power plant near Gillette, Wyoming. The mine-mouth plant, designated Neil Simpson Unit #2 is scheduled to be complete and serving customers by November 15, 1995. The decision to construct was made after reviewing plant retirement needs, customer load growth projections and the cost-effectiveness and timing of other resource alternatives.

ENERGY SALES

Firm energy sales increased in 1993 by 3.5 percent and are forecast to increase over the next ten years at an annual compound growth rate of 2.5 percent. System demand decreased slightly from 1992 due to moderate weather, but is forecast to increase at an annual compound growth rate of 2.6 percent for the ten year planning horizon.

CUSTOMERS

Black Hills Power has 53,330 electric customers with the average residential customer using 8,351 kWhs annually of electricity at an average price of \$0.072 per kWh, which is lower than the average price paid during each of the preceding 5 years. A net increase of 1.5 percent in total customers served continues to reflect the steady growth of the service area. Our cost containment efforts and customer load growth have provided our customers with electricity costs that are declining in real terms.

Northern States Power Company

Northern States Power Company serves about 1.3 million customers in parts of South Dakota, Minnesota, North Dakota, Wisconsin, and Michigan's Upper Peninsula.

In South Dakota the Company serves electricity to over 58,000 customers in thirty-six communities including Sioux Falls, Canton, Garrestson, Dell Rapids, Salem, and Centerville. Peak demand for the South Dakota system was 300 megawatts in August 1991. Sioux Falls customers use about 85% of the South Dakota system load. South Dakota represents about 4% of total NSP system load. Power is supplied to the system predominantly from coal, nuclear, and hydro plants in Minnesota. The Pathfinder generating unit--a 60 MW gas-fired peaking facility is operated in South Dakota.

In addition, the Angus C. Anson combustion turbine project is on schedule and is expected to be ready for commercial operation on January 1, 1995. This project will add two 100 MW gas-fired combustion turbines to the NSP system.

NSP's service territory's once traditional agricultural economy (Morrells, Sioux Falls Stockyards) has been bolstered by non-agricultural expansions (examples)--credit cards, Citibank, Sears Payment Systems, manufacturing, Raven Industries, Hutchinson Technology, Gateway 2000, Medical--Sioux Valley, McKennan, Children's Care Hospital and School and Veterans administration Hospitals; and a thriving regional retail activity.

Construction activity in Sioux Falls surpassed \$166 million during 1993.

NSP is assisting this "Good Thing Going" in the Sioux Falls Area through keeping electric rates among the lowest one-third in the nation. The business environment is extremely competitive today--NSP helps business maintain competitiveness through low rates and assistance in energy management.

Power Company

FIRST-CLASS SERVICE IS A LONG-STANDING COMMITMENT

Otter Tail Power Company's service to South Dakota dates back to 1915. That's when Sisseton and White Rock became the first of 55 South Dakota communities to which the company now provides electric service.

Today, as then, our number one commitment is to provide abundant, reliable, fairly priced electricity to more than 11,000 retail customers in the northeastern section of the state. One indicator of our success is the fact that our average residential customer paid less per kilowatt-hour in 1993 than in 1983.

WE'RE GENERATING MORE THAN ELECTRICITY

Simple logic tells us that the success of our company is directly related to the success of the communities we serve. Our first Economic Development Department was established during the 1950s.

Over the past several years, however, we've greatly expanded our economic development activities.

*Working closely with local economic development groups, state agencies, and our division office staffs, a professional economic development firm retained by the company has helped generate more than 2,500 new jobs throughout our three-state service area. A proportionate number of those jobs have been created in South Dakota.

*Nine South Dakota communities now participate in a loan pool program established in 1989. The pools are designed to provide funds for manufacturing operations that will create additional jobs in communities we serve. By the end of 1993 we had committed \$700,000 to the \$1,800,000 total committed by Otter Tail and other community entities such as banks, savings and loan associations, and other service utilities.

*A third component of our expanded economic development commitment is our Commercial Development Partnership Program, designed to help new retail businesses in the start-up process. A requirement of the program is that the community involved must offer commitment similar to ours, such as tax abatement or credits for sewer, water and refuse collection. Businesses such as telephone companies and other energy providers are encouraged to participate. To date, seven South Dakota communities are participants.

PROPERTY TAXES CONTRIBUTE TO STATE'S ECONOMY

The federal income tax is typically the largest tax bill we have. However, property tax payments to South Dakota taxing authorities were \$1,686,038 in 1993.

It's interesting to note what that means in terms of people. At year-end 1993 we served 8,638 residential customers in South Dakota. This means that our South Dakota property tax bill for the year averaged \$195 per residential customer of the company.

Demographers tell us that each customer represents between two and three persons. So we believe it is fair to say that we pay about \$78 in property taxes in South Dakota for each South Dakotan who uses our electricity.

To be specific, our 1993 liability for county, school, village and city, township, and other property taxes was \$1,257,326 in Grant County, where Big Stone Plant is located.

Northwestern Public Service Company supplies electricity and natural gas to a diverse group of residential, commercial and industrial customers in a 15,000-square-mile area of South Dakota and Nebraska. A high percentage of the Company's 8,200 stockholders live in states where NWPS does business.

At the end of 1993, NWPS provided electricity to 54,288 households and businesses in more than 100 eastern South Dakota communities and natural gas to 34,941 customers in 53 communities. NWPS also served 38,287 natural gas customers in four Nebraska cities.

Natural gas did not just happen in South Dakota. It took the Company and public-spirited groups and individuals 18 years to bring the fuel to the eastern part of the state. By 1934, there were nearly 150,000 miles of natural gas pipelines crisscrossing the United States, but South Dakota was off the beaten path for the natural gas pipeline industry. The distances were too great and the population too small. In 1952, however, Northern Natural Gas of Omaha joined Northwestern in the effort to bring gas to the state. NWPS, Northern Natural, and others worked for four years to obtain the necessary permission from federal regulators in Washington, D.C. When the project received final approval in September 1956, NWPS moved swiftly to build distribution lines to serve 20 communities.

NWPS has continued its investment in the growth and economic health of the region by expanding its natural gas system to serve 10 additional communities in 1993. During the last three years, NWPS has provided the residents of 26 South Dakota communities an economical new fuel option, as well as a new tool for attracting industry into the area. This expansion program was Northwestern's largest gas expansion project since introducing natural gas in 1956 and 1957.

To maintain and improve electric operations, the Company is in the process of upgrading its transmission system, installing new computer equipment for its system control center, and negotiating coal supply and transportation contracts to save money on baseload generating costs. Baseload generation is supplied by coal, and NWPS is a partner in three generating plants for a total of 203 megawatts of power. The company has 19 oil- and gas-fired combustion units to provide the necessary power to meet peaking conditions. The latest addition to the system was a 43,000-kilowatt peaking plant in Huron, S.D., in 1992. The Company completed the installation of the plant's water injection system in 1993 to reduce nitrogen oxide emissions.

Changes in federal regulations for both the gas and electric industries promise to create new opportunities for NWPS over the next few years, and the Company is reorganizing its operations to help meet the challenges of a more competitive marketplace. Among other recent changes at NWPS are some changes in management. In February 1994, Robert A. Wilkens retired as president and chief executive officer (CEO) and succeeded Albert D. Schmidt as chairman of the Board of Directors. The Board elected Merle D. Lewis as the president and CEO.

Montana-Dakota Utilities Co. owns and operates natural gas distribution systems in the Black Hills and central South Dakota plus electric transmission and distribution facilities in north-central South Dakota. The Company serves 32,391 natural gas customers and 8,668 electric customers in the state.

Montana-Dakota Utilities Co., which has been part of the state's business community since 1928, is currently enlarging its presence through the expansion of natural gas distribution systems in Pierre, Mobridge and other towns in central South Dakota.

The Company also operates natural gas systems in many Black Hills cities and electric properties in several north-central towns. The Company has also been involved in the promotion of natural gas as a vehicle fuel. Now, over 450 vehicles operate on natural gas supplied by 13 refueling stations located throughout North Dakota, South Dakota, Montana and Wyoming, which comprises Montana-Dakota's service area. Two public refueling stations are located in the Rapid City area and one private system operates in Spearfish. Along with providing energy to South Dakota customers, Montana-Dakota employees participate in community activities including economic development plus public education and safety organizations. Many Montana-Dakota employees also participate in the Company's Gatekeeper program. This program is designed to uncover problems with the elderly and the handicapped. Utility employees regularly come in contact with all customers and act as "eyes and ears" to relay information to local service agencies that can help elderly and handicapped citizens.

Montana-Dakota is indeed a partner in the communities it serves. In addition to providing energy and a large payroll, Montana-Dakota is also a major taxpayer. In 1993 the Company paid property taxes of \$962,000 in South Dakota.

Montana-Dakota is a business unit of MDU Resources Group, Inc., a multidimensional natural resources enterprise traded on the New York Stock Exchange. The utility offers electric power generation and transmission plus natural gas, propane and electricity distribution to customers in North Dakota, South Dakota, Montana and Wyoming. The corporation also operates a natural gas pipeline company, coal and aggregate mining operations, an energy marketing firm, as well as oil and natural gas production investments.

South Dakota Intrastate Pipeline Company (SDIPC) was formed in 1992 to transport natural gas from the Northern Border Pipeline in Edmunds County to Pierre, in Hughes County. SDIPC also provides gas to interested communities and businesses along its route.

In March of 1992 SDIPC filed with the South Dakota Public Utilities Commission (SDPUC) for a certificate to construct and operate a pipeline consisting of 47 miles of 8" pipe, 106 miles of 6" pipe, and 25 miles of 3" pipe, and the associated valves, meters, and fittings. The pipeline is designed to operate at a pressure of 1130 psig and was built to meet or exceed federal safety requirements and the requirements of the SDPUC. The SDPUC granted site permission in July of 1992 and an interim rate in January of 1993, with a final rate approved in December 1993 after construction costs were finalized. SDIPC began construction in April of 1993 and went into operation on September 1, 1993.

SDIPC currently transports gas to 7 communities along its pipeline route for a distribution company, Montana Dakota Utilities. Revenues for 1993 were approximately \$71,000 and expenses were approximately \$210,000. The final cost of construction was approximately \$13,900,000. SDIPC currently employs 5 people and will add 2 or 3 more in 1994.
