Pursuant to the Settlement Stipulation in Docket No. EL14-072, MidAmerican Energy Company (“MidAmerican”) is required to perform quarterly reviews of its Clause ECA – Energy Cost Adjustment. Per the Stipulation, when the projected cumulative account balance divided by projected jurisdictional sales equals or exceeds \pm \$0.001, a revised ECA factor will be determined and filed for implementation with the next month's billing cycle.

MidAmerican submits the quarterly review for the period ending October 31, 2017. The revised factor of \$(0.00910) will become effective with billings on November 30, 2017. MidAmerican also submits the following revised electric tariff sheet:
