Dear Ms. Van Gerpen:

Pursuant to Section No. 3, Sheet No. 33.1 (5) of NorthWestern's Electric Tariff, enclosed is 288th Revised Sheet No. 33a and 69th Revised Sheet No. 33b.

Sheet Nos. 33a and 33b reflect changes in the delivered cost of fuel, delivered cost of energy and ad valorem taxes paid to be effective August 2, 2015.

The effect of Sheet Nos. 33a and 33b for a typical Rate 10 residential service customer using 750 Kwh per month would be an increase in the monthly cost of \$2.03. The new monthly cost effective August 2, 2015 is \$93.95. This includes the interim rate increase that became effective July 1, 2015.
