PETITION FOR INTERVENTION BY AT&T COMMUNICATIONS OF THE MIDWEST, INC.

Pursuant to ARSD Sec. 20:10:01:15.02, AT&T Communications of the Midwest, Inc., ("AT&T") petitions for leave to intervene in the above captioned proceeding.

- 1. AT&T is an interexchange telecommunications carrier authorized to do business in South Dakota.
- 2. As an interexchange carrier, it is required to pay intrastate access fees to competitive local exchange carriers (CLECs), such as Native American Telecom, LLC ("NAT") which aspires to become a CLEC within MidState's study area as outlined in Application for Certificate of Authority.
- 3. Based upon NAT's Application for Certificate of Authority, NAT subsidizes the telecommunications services by providing them free of charge to Tribal Members. <u>See</u>, Application, p. 5. It is not clear from the Application what revenues NAT is using to subsidize these telecommunications services.
- 4. As an interexchange carrier who may pay access charges to NAT, AT&T has an interest in the source of subsidization for NAT's telecommunications services to its consumers,
- 5. AT&T has a direct interest in the outcome of this proceeding which may directly or indirectly affect the cost of telecommunications services that it provides to its long distance customers in South Dakota. Pursuant to ARSD 20:10:01:15:05, it qualifies for intervention as its interest is distinguishable from an interest common to the public or taxpayers in general.

WHEREFORE, AT&T requests that it be granted intervention status in this proceeding.
