In support of this Motion, the Parties submit as follows:

1. This Joint Motion is made pursuant to ARSD 20:10:01:19.
2. The Amended Settlement Stipulation resolves all of the issues between these Parties in EL14-026.
3. The terms of the Amended Settlement Stipulation represent a negotiated settlement of all of the issues between these Parties in Docket No. EL14-026.
4. The terms of the Amended Settlement Stipulation agreed upon are just and reasonable and consistent with South Dakota law.

WHEREFORE, for the foregoing reasons, the undersigned Parties jointly request the Commission to: 1) grant the Joint Motion for Approval of Amended Settlement Stipulation, 2) adopt the attached Amended Settlement Stipulation without modification for the purpose of resolving all issues in this proceeding, and 3) enter an Order finding that the attached Amended Settlement Stipulation results in just and reasonable rates for customers of Black Hills Power, Inc.
