The South Dakota Public Utilities Commission (Commission) revoked H & I Grain of Hetland, Inc.'s (H & I Grain) grain buyer's license on July 24, 2017, in Docket No. GW17-001. In that Order, the Commission ordered a new docket be opened to address the disbursement of the bond proceeds pursuant to SDCL 49-45-19.

Upon revocation, Commission staff (Staff) opened a new docket, GW17-002, and sent claim forms to all persons that Staff determined to have sold grain to H & I. Included with each claim form was a description of Staff's finding of what was owed to each seller. Upon the expiration of the statutory time for submitting claims to the Commission, Staff drafted a recommendation for distribution of the \$400,000 grain bond plus accumulated interest, along with a memorandum supporting Staff's recommendation. Staff filed its Memorandum in Support of Distribution of Bond Proceeds and a Table of Bond Payouts (Attachment 2) on March 8, 2018. On March 12 and 29, 2018, Staff filed an Amended Attachment 2.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-45 and ARSD 20:10:12.

At its regular meeting on April 3, 2018, the Commission considered the distribution of the grain bond and accumulated interest. The Commission voted unanimously to accept the recommendation of Staff and distribute the bond proceeds accordingly.

It is therefore

ORDERED, that the bond proceeds shall be distributed as detailed in the Attachment. It is further

ORDERED, that the percentages listed in the Attachment shall be controlling should any changes, such as amount of interest, to the bond occur.
