American Resources Group, Ltd. (ARG), has been requested by ENSR International, Fort Collins, Colorado, to conduct the cultural resources survey of the Oklahoma segment of the TransCanada Keystone Pipeline Project, Cushing Extension. TransCanada, pending authorization from the U.S. Department of State (DOS), is proposing to construct an approximate 1,870-mile-long crude oil pipeline extending from Hardisty, Alberta, to Patoka, Illinois. More information regarding this project can be obtained by referring to the project website at www.transcanada.com/keystone.

The Cushing Extension represents a lateral extension of the Keystone Pipeline from a point near the Nebraska-Kansas border to Cushing, Oklahoma (see attached map). The Cushing Extension crosses 79.66 miles in Oklahoma and passes through the counties of Kay, Noble, and Payne.

The purpose of this letter is to provide information on the proposed pipeline project and its location. The DOS, as the lead federal agency, will be responsible for all government to government consultation with Native American groups that may have an interest in portions of the proposed pipeline corridor.

Weather permitting, ARG will begin the field investigations in Oklahoma in March 2007. These investigations will be carried out by two four-person crews employing methods that conform to the Oklahoma State Historic Preservation Office guidelines. The survey will be conducted within a 300-foot-wide corridor centered on the proposed pipeline centerline and will be accomplished using a variety of field techniques including systematic surface survey, systematic shovel testing, systematic walkover survey, and geomorphological and geoarchaeological investigations. All fieldwork will be confined to the area within the 300-foot-wide survey corridor.



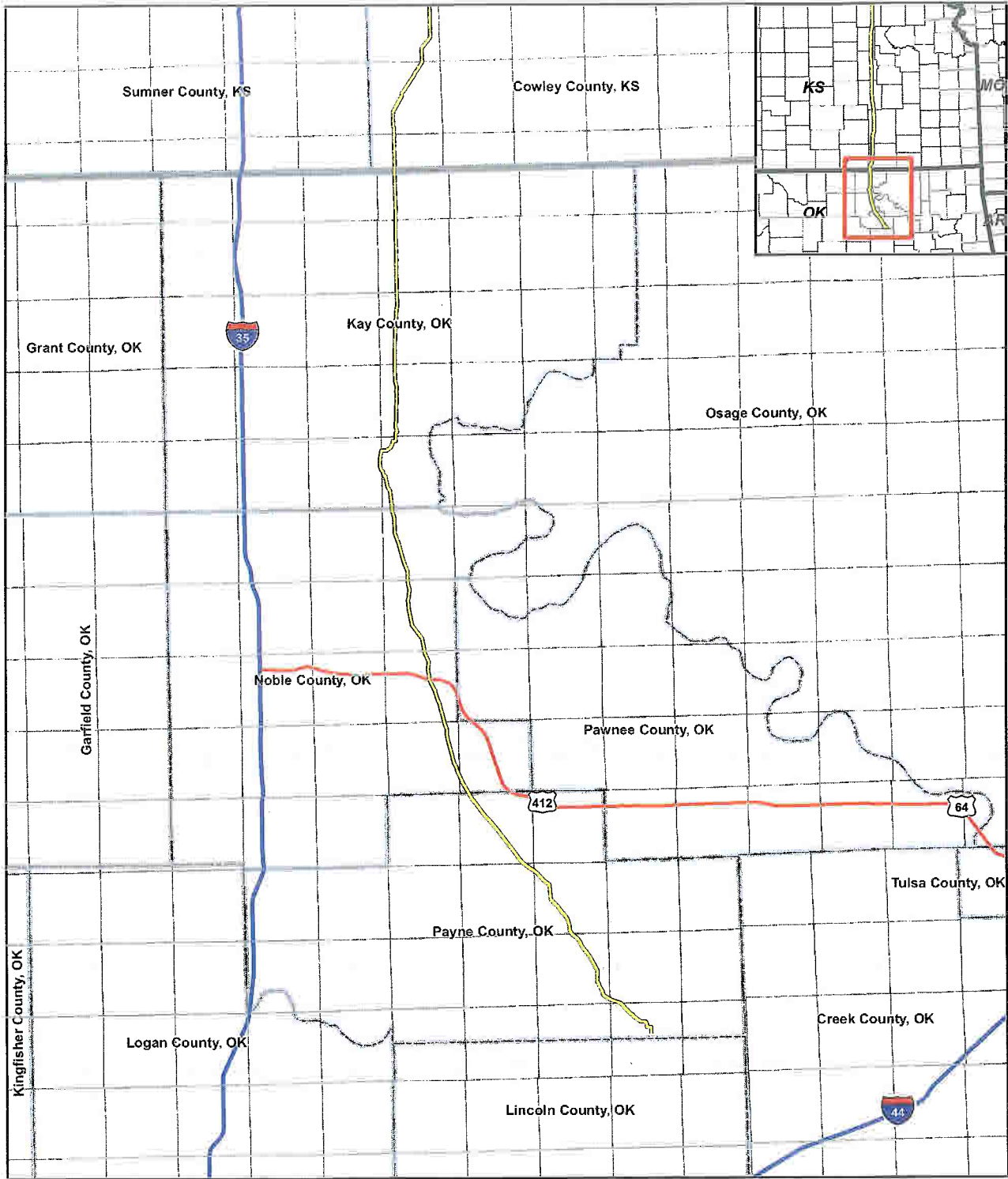
