Joshua Thompson Land Representative, U.S. Land Management Calvin Heitzman, representing Keystone tract numbers ML-SD-HA-0840 and 0842, has contacted Josh complaining about items he says he was not compensated for. A copy of the settlement agreement for 0840 (0842 is the same) is attached for reference. He is wanting compensation for feed for his cattle, and for rock that he says he wanted to keep. My understanding of the settlement agreement is that it covers all damages related to the construction and installation of the pipeline, including crops such as hay. If Mr. Heitzman had to buy hay for his cattle, I believe that is already covered in the settlement agreement. Regarding the rock, if he had ever filled out a construction conditions agreement requesting the rock, then he might have a valid claim, but he did not. I have contact reports where the land agent attempted to meet with him multiple times but he always set he did not have the time. The land agent finally mailed it to him so he could fill it out, but he never did. Can you confirm that Mr. Heitzman's damages were covered by the settlement agreement and there is nothing more owed to him? Please advise.




