Dakota Rural Action (“**DRA**”) hereby provides notice to the South Dakota Public Utilities Commission (the “**Commission**”), to TransCanada Keystone Pipeline, LP (“**TransCanada**”), and all other named Intervening Parties of the following supplemental information with respect to its list of exhibits previously filed.

With respect to DRA Exhibit No. 409, DRA previously provided notice on July 9, 2015, that such exhibit consisted of a DVD/video produced by Michael and Sue Sibson documenting the condition of their land subsequent to TransCanada’s failure to properly reclaim it following construction of the Keystone 1 pipeline in South Dakota. This exhibit was first obtained by DRA last week and was intended to be offered for the purpose of demonstrating that, promises aside, TransCanada cannot be relied upon to adequately reclaim land owned by South Dakota’s farming and ranching families post-pipeline construction. While the Commission entered its order excluding this exhibit, among others, DRA is filing this notice to ensure the video is a matter of public record, to preserve its rights as to any subsequent appeals, and to provide all parties with access to the video. This notice is also being filed concurrently with DRA’s motion for reconsideration of the Commission’s order partially excluding DRA’s exhibits. This notice and disclosure is further intended to supplement DRA’s responses to TransCanada’s discovery requests and to publicly disclose this exhibit to TransCanada in lieu of a formal discovery response.
