9 COMES NOW the Rosebud Sioux Tribe – Tribal Utility Commission, by and through  
10 their attorney Mary Turgeon Wynne, and moves to join Intervener Yankton Sioux Tribe's  
11 Motion to Dismiss the TransCanada Keystone Pipeline LP's Petition for Certification.

- 12 1. On December 1, 2014, Intervener Yankton Sioux Tribe filed a Motion to Dismiss  
13 TransCanada Keystone Pipeline LP's Petition for Certification of the Keystone XL  
14 Pipeline, pending before the South Dakota Public Utility Commission.
- 15 2. The Motion to Dismiss by the Yankton Sioux Tribe in all ways applies with equal force  
16 to the Rosebud Sioux Tribe - Tribal Utility Commission.
- 17 3. Based on the aforementioned, the Rosebud Sioux Tribe - Tribal Utility Commission  
18 believes it is appropriate and necessary to join in the Yankton Sioux Tribe's Motion to  
19 Dismiss.
- 20 4. Therefore, the Rosebud Sioux Tribe - Tribal Utility Commission moves the South Dakota  
21 Public Utility Commission to enter an order permitting the Tribal Utility Commission to  
22 join in the Motion to Dismiss previously filed by the Yankton Sioux Tribe.
