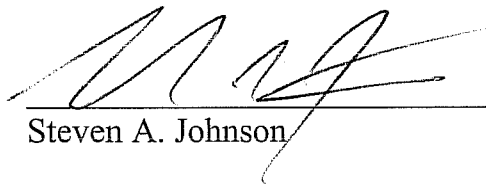

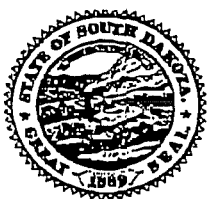

The long distance service was purchased for \$26,262.56. There were a total of four packages purchased, one of which was exclusively for Brookings Auto Mall, LLC, a South Dakota foreign LLC. Copies of the Switching Forms completed by S&S are attached.

Although Brookings Auto Mall, LLC is a North Dakota limited liability company, it is registered to do business in South Dakota. In fact, its business operations take place solely and exclusively in Aberdeen, South Dakota where it operates an automobile dealership and employs approximately 39 people. The package purchased by Brookings Auto Mall from S&S was purchased for use from this facility in South Dakota.
