


**MOTION FOR PARTIAL
SUMMARY JUDGMENT**

WWC License LLC, of 3650 131st Avenue, SE, Suite 400, Bellevue, Washington 98006 (hereinafter "WWC"), by and through its attorney, Talbot J. Wieczorek of Gunderson, Palmer, Goodsell & Nelson, LLP, hereby submits this Memorandum in Support of its Motion for Partial Summary Judgment.

WWC requests the Commission grant its Motion for Partial Summary Judgment with respect to three issues: (1) the Commission's jurisdiction over the matters presently before it; (2) immediate payment of undisputed overage charges; and (3) the applicability of interest to the overage charges. Summary judgment is proper because there is no genuine issue of material fact regarding these issues, and therefore WWC is entitled to judgment as a matter of law. S.D.C.L. § 1-26-18. This motion is asserted against all the Golden West companies except for Kadoka Telephone Company.


