

Thank you for your patience in allowing WWC to determine whether it would call a witness to rebut the testimony of the Golden West companies' surprise witness, Mr. Musick. As I previously conveyed, because the opinions offered by Mr. Musick had not been disclosed or even discussed during the discovery periods, at the time of Mr. Musick's testimony, WWC did not have a witness. We do intend to call a witness in rebuttal to Mr. Musick.

Joe Oliver is the individual who we will be calling to provide that testimony. Mr. Oliver is employed at Alltel Communications, Inc. as Senior Application Programmer in Messaging Processing Systems.

Please let me know how you would like to schedule Mr. Oliver's testimony. In order to minimize disruption of his normal responsibilities and to expedite his appearance, we would be willing to have him appear via telephone.


On an unrelated issue, we have noticed that the refund spreadsheets submitted by WWC contain a formula error. The formula error results from subtracting interMTA minutes from total minutes delivered before calculating the reciprocal compensation amount due to WWC. The contract clearly calls for WWC receiving reciprocal compensation based on all traffic delivered. Because the contract is clear under Appendix A, Section 4.0, it would appear that I could simply point this correction out in the post hearing briefing. Still, since the record is still open, perhaps the Commission would prefer that I make a motion to allow supplementation of the record with a
