Our household has been receiving telemarketing calls from DISH Network or firms represent. Dish Network.

I originally filed my complaint with the South Dakota Attorney General's Office. The Attorney General's Office took up my complaint to which DISH Network denied ever calling my home. I have supplied the At Gen Office with various phone numbers from which these calls originated. Most originate from within the U.S. although some came from CANADA

My attempts at requesting to have my phone number removed from their list have resulted in DISH Network cutting the connection before my request has been made. Additionally DISH Network will hang-up on me if I request company information from them.

All of these phone calls, which have numbered up to 4 or 5 per day at times are unwanted, unsolicited and incessant.

RESOLUTION REQUEST


I ask that the Public Utilities Commission grant the following remedy. (What do you think the Commission should do to solve your complaint? Be specific in your request for a resolution.)
