Complaint

These are the facts giving rise to my complaint :

I have a business opportunity to lease the Stardust Motel in Mitchell, SD, and called Northwestern Public Service to request utilities. Northwestern's legal department requested a notarized lease for the property. I then sent the lease notarized as requested by Lori from Northwestern's legal department via fax.

I contacted Lori in Northwestern's legal department confirming the receipt of request, she confirmed that the request was in and questioned the authenticity of the Notary Public who signed it. I then faxed the lease with the notary seal darkened in pencil for easier viewing after being informed by Lori that she could not see the seal. 
