For good and valuable consideration mutually acknowledged by the parties hereto, it is hereby agreed by and between **Dakota Energy**, **Inc. (Dakota)** and the **City of Miller**, Hand County, South Dakota (Miller), as follows:

WHEREAS, Dakota Energy has heretofore provided electric service to a drive-in theater located immediately east of Miller, South Dakota, situated upon the following described real property, to-wit:

Beginning at a point 38.4 feet south of the Northwest corner of Section Thirteen (13), Township One Hundred Twelve North (112N), Range Sixty-Eight (68), and extending North 711.7 feet to a point 250 feet South of the Center Line of the Highway 14 Running between Miller and St. Lawrence, South Dakota, thence East along a line parallel with said Highway 14 a Distance of 633 feet, from the Section Line Between Sections Eleven (11) And Twelve (12) in said Township, thence South 712.8 feet, thence West 633 feet to the point of beginning, said land being all located in Sections Twelve (12) and Thirteen (13) in said Township One Hundred Twelve North (112N), Range Sixty-Eight (68), West of the 5<sup>th</sup> P.M., Hand County, South Dakota.

WHEREAS, the owner/operator of such real estate and drive-in theater wishes to have three phase electrical service provided to such real estate location, for the purpose of operating a drive-in theater at such location;

WHEREAS, Miller has three phase electrical service only a short distance from the subject location, and Dakota has no nearby three phase service;

WHEREAS, it is mutually advantageous to the owner/operator of the above premises to Dakota and to Miller that the provision of three phase service at such location for the purpose of operating a drive-in theater and the right to sell electrical energy to such customer at such location be transferred from Dakota to Miller;

WHEREAS, the owner/operator is also amenable to such transfer and the purchase of such three phase power from Miller;

### THEREFORE, IT IS HEREBY AGREED:

1. Dakota consents to Miller providing three phase electrical service to the customer at the above described location for the purpose of operating a drive-in theater at such location.



On June 5, 2001, the Public Utilities Commission (Commission) received a joint request from Dakota Energy Cooperative, Inc. (DEC) and the City of Miller (Miller) seeking approval of an agreement for a service rights exception. The purpose of the filing was to seek Commission approval for an exception to the existing electric service territorial agreement. According to the application, the agreement seeks an exception of service territory as the owner/operator of the drive-in theater wishes to have three phase electrical service provided for the purpose of operating a drive-in theater and Miller has three phase electrical service only a short distance from the location and DEC has no nearby three phase service. The service exception shall apply for as long as the property is used as a drive-in theater. The owner/operator is agreeable to such exception and the purchase of three phase power from Miller. The legal description is as follows:

Beginning at a point 38.4 feet south of the Northwest corner of Section Thirteen (13), Township One Hundred Twelve North (112N), Range Sixty-Eight (68), and extending North 711.7 feet to a point 250 feet South of the Center Line of Highway 14 running between Miller and St. Lawrence, South Dakota, thence East along a line parallel with said Highway 14 a Distance of 633 feet, from the Section Line between Sections Eleven (11) and Twelve (12) in said Township, thence South 712.8 feet, thence West 633 feet to the point of beginning, said land being all located in Sections Twelve (12) and Thirteen (13) in said Township One hundred Twelve North (112N), Range Sixty-Eight (68), West of the 5th P.M., Hand County, South Dakota.

On June 19, 2001, at its regularly scheduled meeting, the Commission considered the request for approval of a service rights exception. Commission Staff recommended approval.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL 49-34A, specifically, 49-34A-4, 49-34A-42, and 49-34A-55. Further, the Commission finds that the service rights exception is in the public interest and the request shall be granted. As the Commission's final decision in this matter, it is therefore

ORDERED, that the request seeking approval of a service rights exception is hereby granted.
