Dear Ms. Bonrud,

Southeastern Electric Cooperative, Inc. (SEC) has received a request for three-phase electric service for irrigating approximately 65 acres of land by Mr. Ron Hulshof of Sioux Center, Iowa. His request is for a three-phase electric service in the North 65 acres of the Northwest Quarter of Section 24, Range 48 West, Township 96 North, Lincoln County. This location is in the SEC's service territory as established by our Territorial Agreement in 1976.

In order for SEC to provide three-phase electric power to this location, a line extension of over 3 miles of three-phase line would be required as noted on the attached Map titled "Attachment A". In my conversations with Mr. Hulshof he has indicated to me that he has received the appropriate water approvals from the Department of Environment and Natural Resources for an irrigation permit at the above location. SEC has informed Mr. Hulshof that with a construction project of this nature it would require a sizeable aid to construction by SEC from Mr. Hulshof for a seasonable load of this nature. Since SEC is not able to provide three-phase electric service to this site without a sizeable aid to construction he is willing to allow MidAmerican Energy to provide electric service to this site. Mr. Hulshof has provided a letter indicating his request for service and his desire to move forward with a transfer of service to MidAmerican Energy as noted in "Attachment B".

Mr. Hulshof has contacted MidAmerican Energy employee, Jeff Treinen and they do have electric facilities located within a short distance of Mr. Hulshof's proposed irrigation pumping site. Based on this information I provided Mr. Treinen with a copy of the letter sent by Mr. Hulshof and a form titled "EXCEPTION TO SERVICE ON ASSIGNED AREAS" for him to sign and return to SEC. Mr. Treinen has signed those documents and a signed copy of that agreement is enclosed for you to review and is listed as "Attachment C".

We believe that this exception meets the factors as outlined in SDCL 49-34A-55. As a result, we would like to request formal approval by the South Dakota Public Utilities Commission on this matter as soon as possible. Given the fact that all parties are in agreement on this issue, we cannot foresee any difficulties and look forward to hearing from you in the near future.



Mr. Schardin:

I have been approved by the State of South Dakota to dig a well and irrigate the north 65 acres of the N1/2NW1/4 of 24-96-48, Eden Township, Lincoln County, South Dakota.

In order to power the pump for the well water, and to power the tower motors for the irrigator, I need 3 phase 480V power.

I have inquired of your office to provide the power, and you have advised me of the related costs and difficulties. Because of these facts, I have no objection to your company giving the rights of electrical service for my needs to Mid American Energy.

Please process the documentation necessary to allow Mid American Energy to provide the power for this service, so I can move quickly toward well digging and irrigating the property this spring.
