On January 18, 2006, the Commission issued its Scheduling and Procedural Order. On March 31, 2006, Commission issued its Second Scheduling and Procedural Order, canceling the original procedural schedule, establishing a revised procedural schedule and making certain additional procedural rulings. The procedural history preceding these orders is set forth in these orders. On May 8, 2006, Minnesota Center for Environmental Advocacy (MCEA) on its own behalf and on behalf of its co-intervenors, Minnesotans for an Energy-Efficient Economy, Izaak Walton League of America - Midwest Office, and the Union of Concerned Scientists, filed a Motion to Compel Discovery and to Extend Deadline for Intervenor Testimony (Motion). On May 12, 2006, Applicants and MCEA filed a Joint Motion and Stipulation to Amend Second Scheduling and Procedural Order (Stipulation), in which MCEA agreed to withdraw its Motion to Compel, Applicants agreed to respond to MCEA's discovery request IR 17, and Applicants and MCEA agreed to certain modifications of the procedural schedule in the Second Scheduling and Procedural Order to provide additional time for the filing of certain MCEA testimony responsive to the information provided by Applicants' response to IR 17. In this order, the Commission modifies the procedural schedule set forth in the Second Scheduling and Procedural Order to conform to the Stipulation. Other than the specific modifications to the procedural schedule itself contained herein, all other procedural rulings in the original Scheduling and Procedural Order as modified by the Second Scheduling and Procedural Order shall remain in effect. The Commission will formally consider approval of the Joint Motion and Stipulation to Amend Second Scheduling and Procedural Order at its May 23 Commission Meeting, and the parties may address any remaining scheduling or other issues related to the Motion and Stipulation at such time.

Due to a scheduling conflict with another matter, the Commission is also moving the time that had been set for Pre-Hearing Motions on June 13, 2006, in Sioux Falls from 10:30 a.m. to the later of 2:30 p.m. CDT or immediately following the Commission Meeting commencing at 1:30 p.m.
