Pursuant to SDCL 49-41B-17 and ARSD 20:10:22:40, the following organizations each apply for party status in the above-referenced proceeding: Minnesotans for an Energy-Efficient Economy ("ME3"), Izaak Walton League of America -- Midwest Office ("IWLA"), and Minnesota Center for Environmental Advocacy ("MCEA"). SDCL 49-41B-17 (3) provides that parties to energy conversion facility permitting proceedings include "any nonprofit organization, formed in whole or in part to promote conservation or natural beauty, to protect the environment, personal health or other biological values . . . to promote consumer interests . . . or to promote the orderly development of the areas in which the facility is to be sited[.]" ME3, IWLA and MCEA each meet the definition of a party under SDCL 49-41B-17 (3).

ME3 is a non-profit organization, working in the public interest to increase commitments to renewable energy, energy efficiency in homes, government and business, to protect public health and quality of life, and to promote an energy-efficient economy.


IWLA is a nonprofit conservation organization committed to protecting fish and wildlife, critical habitat, air and water resources. The Midwest Office of the IWLA works on energy and air quality issues throughout the Midwest.

MCEA is a nonprofit environmental organization that works in the courts, the legislature and state agencies to protect Minnesota's wildlife, natural resources and the health of its people. 
ME3, IWLA, and MCEA respectfully request that the Commission grant them each party status in this proceeding.

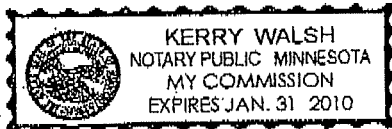


