



The Big Stone II Project, by and through its undersigned attorneys of record, respectfully requests the Commission hold a prehearing conference pursuant to SDCL 49-41B-14 to discuss and resolve the following issues with the parties:

1. Date and location of final hearing on Big Stone II Application;
2. Appropriate representation of parties and pro-hac vice admission of attorneys;
3. Specific issues that will be contested at hearing;
4. Production of discovery materials via electronic means; e.g. posting of documents in a virtual reading room;
5. Deadline for conducting discovery;
6. Deadlines for submitting written testimony and exhibits as may be directed by the Commission pursuant to ARSD 20:10:01:22.06 including:
 - a. Direct testimony in support of application;
 - b. Direct testimony of intervenors; and
 - c. Rebuttal testimony.
7. Deadlines for submissions of proposed findings of fact, conclusions of law and order; and
8. Submission of post-hearing briefs or memoranda as may be requested by the Commission.


