With this letter, NorthWestern Corporation ("NorthWestern" or the "Company"), doing business as NorthWestern Energy, is filing with the Commission a proposed electric contract with deviation. Pursuant to ARSD 20:10:13:39, the Company states:

- (1) The documents submitted with this filing include:
 - The Application for Tariff Change and Report in Support of Tariff Filing of NorthWestern (the "Report"), pursuant to ARSD 20:10:13:26;
 - The proposed revised tariff schedule, Section 4, Sheet 1. 4th Revised
 - A map of the proposed route
 - Schedules detailing the cost of the project
 - A copy of the contract between NorthWestern and the Customer.
- (2) The proposed effective date for the new tariff is April 1, 2008.
- (3) The names and addresses of those to whom copies of the rate schedule have been mailed:

NorthWestern is proposing the Contract With Deviation to construct an electric line to serve the Burlington Northern Railroad. This project is to provide electrical service to a new switch heater located at Line Segment 2001, Milepost 736.68, City of Redfield, Spink County, South Dakota. The heater will only run when the temperature is below zero and the tracks are wet. There is a very minimal load associated with this heater.

NorthWestern proposes to serve this heater with a 25kVA pad mount transformer. We will hire a contractor to do all of the boring and plowing that is associated with this project, as there is approximately 825 feet of 1/0 primary cable to be buried.

The estimate of the project cost is \$9,000.00. The payment has been received from the customer and will be applied to the project costs at the date of completion. NorthWestern plans to begin work on this project after April 1st.

(5) Reasons for the proposed changes:

The reason for the proposed change is the customer's need for additional electric line to serve its new track heaters.

(6) Number of customers whose cost of service will be affected and annual changes in cost of service to such customers:

Burlington Northern will be the only customer impacted by this filing.
