Dear Interested Party:

The Western Area Power Administration (Western) has prepared a Draft Environmental Impact Statement (EIS) on Basin Electric Power Cooperative's (Basin Electric) proposal to interconnect their proposed Deer Creek Station Energy Facility Project (Project) to Western's power system at the existing White Substation in Brookings County, South Dakota. Basin Electric is proposing to construct, own, operate, and maintain a 300-megawatt natural gas-fired, combined cycle generation facility, a 13.2-mile-long natural gas pipeline, two water wells and a 1.25-mile-long water pipeline, a 0.75-mile-long 345-kilovolt transmission line, and associated access roads and interconnection facilities near White, South Dakota. Enclosed is a copy or copies of the Draft on this proposed Project, in hard copy or CD form as you have requested.
