We the undersigned residents who are both taxpayers and customers of Black Hill Power, wish to express the following opinions and concerns. The company's request for a 26.6% increase in the electricity rate is UNFAIR for the following reasons:

SOUTH DAKOTA PUBLIC UTILITIES COMMISSION

#1. The economic impact on the consumer is far greater than the utility company indicates. They estimate the typical monthly bill will increase about \$18.00 based upon a monthly usage of 600 kw. Only the smallest of users fall into this category. The company needs to defend this claim. It should also be noted that the impact on the consumer does not end with his/her monthly bill. Every entity that we do business with will be raising their rates to offset the losses that they would incur. Everything trickles down to the "little guy" consumer.

#2. Any investment cost into the development and construction of new generating facilities should be born by the utility. How many industries have the luxury of funding expansion through consumer investment years before the expansion is realized. One could also question the logic of this expansion when the energy policies of this nation are in turmoil. What is the future of "Cap and Trade" and other energy policies that only burden the consumer. Is this going to be the next reason for seeking additional increases in the rates.

#3. In addition to believing that expansion investment by a company is the responsibility of the stockholders, so is the responsibility of company management. If losses by a company are incurred through actions of their own, they should accept the losses. To use over 11% of the proposed rate increase for dividends to be paid out is not acceptable. This sounds so much like the corporate bail-outs we read about every day. We the people are expected to pay the bill.
















