Not a problem. I understand how emotional and difficult an issue this can be.

I can promise you this is not a done deal. We haven't made any decision on the merits of the case, and Black Hills Power has a great deal to prove before any final increase would be approved. At the end of the day though, I know that Black Hills Power customers won't be required to pay for any expenses that weren't prudently incurred or that they didn't receive some benefit from.

Your email isn't a burden . . . I wish more people were motivated enough to email. Most just sit and grumble. Let me know if you have other questions.
