On September 30, 2009, Black Hills Power, Inc. filed an application with the South Dakota Public Utilities Commission (SDPUC) for a rate increase for Black Hills Power's electric customers to recover costs associated with the Wygen III power plant, other generation, transmission and distribution system investments and increased operating expenses incurred during the past four years. In its request, Black Hills Power sought a 34.2 percent increase in base rates across all South Dakota customer groups.

On Month XX, 2010, the SD PUC authorized a xx percent increase in annual utility revenues, with new rates effective for service on and after April 1, 2010.

When compared to the rates in effect prior to Black Hills Power's rate application, a typical residential customer using 600 kilowatt-hours (kWh) of power each month will see an increase of \$10.99 per month or \$0.36 per day. The actual change in each customer's monthly utility bill will vary based on their electric service rates and electricity use.

Black Hills Power will issue a refund to customers, with interest, for the difference between the interim rates that had been implemented and final approved rates effective for electricity service on and after April 1, 2010.


