Legal Description of the Electric Service Territory Boundary between Traverse and Lake Region

Based on a prior agreement dated the 6th day of August, 1975, signed Traverse Electric Cooperative, Inc. (Traverse) and Lake Region Electric Association, Inc. (Lake Region), the following represents the legal description of the electric service territory boundary shared between Traverse and Lake Region.

BEGINNING at the North Dakota/South Dakota border at the NE corner of Government Lot 2 of Section 26 of Township 129 North (T129N) Range 53 West (R53W), Marshall County,

THENCE continue south to the SE corner of the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 35 of T129N, R53W,

THENCE continue east to the NE corner of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 36 of T129N, R53W,

THENCE continue south to the SE corner of the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 12 of T128N, 53W,

THENCE continue south-east to the Marshall/Roberts County border to the NE corner of Section 13 of T128N, R53W,

THENCE continue south following the Marshall/Roberts County border to the SE corner of Section 13 of T128N, N53W,

THENCE continue west to the SE corner of the SW $\frac{1}{4}$ of Section 14 of T128N, R53W,

THENCE continue south to the SE corner of the NW $\frac{1}{4}$ of Section 35 of T128N, R53W,

THENCE continue west to the SE corner of the NW $\frac{1}{4}$ of Section 34 of T128N, R53W,

THENCE continue south to the SE corner of the SW $\frac{1}{4}$ of Section 22 of T127, R53W,

THENCE continue east to the Marshall County/Roberts County border at the NE corner of Section 25 of T127N, R53W,

THENCE continue south along the Marshall/Roberts County border to the SE corner of the NE ¼ of Section 13 of T126N, R53W,

THENCE continue west to the SE corner of the NW ¼ of Section 14 of T126N, R53W,

THENCE continue south to the SE corner of the NW ¼ of Section 23 of T126N, R53W,

THENCE continue east to the NE corner of the SW ¼ of Section 24 of T126N, R53W,

THENCE continue south to the SE corner of the NW ¼ of Section 25 of T126N, R53W,

THENCE continue east to the NW corner of the SE ¼ of Section 30 of T126N, R52W, Roberts County,

THENCE continue south to the SW corner of the NE ¼ of Section 31 of T126N, R52W,

THENCE continue west to the SW corner of the NE ¼ of Section 36 of T126N, R53W, Marshall County,

THENCE continue east to the NE corner of Section 3 of T125N, R52W.
