

**CONSENT AND AGREEMENT FOR
ELECTRIC SERVICE IN
ASSIGNED SERVICE TERRITORY
OF ANOTHER ELECTRIC SUPPLIER**

As agreed between NorthWestern Corporation, d/b/a NorthWestern Energy (**NorthWestern**), 600 Market Street West, Huron, South Dakota 57350-1500 and Bon Homme, Yankton Electric Association, Inc. (**B-Y Electric**) P.O. Box 158, Tabor, South Dakota.

NorthWestern has assigned territorial rights to provide Electrical Service to the Northwest Quarter (NW1/4) of the Northwest Quarter (NW1/4) of Section Fourteen (S14), Township (Mission Hill South) Ninety-three North (T.93 N.), Range Fifty-six West (R.56 W.) of the Fifth (5th) Principal Meridian, Yankton County, South Dakota. By this Consent and Agreement **NorthWestern** hereby agrees to allow **B-Y Electric** to supply a single phase electric service to a B-Y Water District Pressure Reducing Valve and Vault located within its assigned service territory (see attached Exhibit A), pursuant to South Dakota Codified Law 49-34A-55 and the provisions of this Consent and Agreement.

The execution of this Consent and Agreement is made with the understanding and agreement that the land described herein shall remain a part of the assigned service area of **NorthWestern**, and that by virtue of this Consent and Agreement, **B-Y Electric** does not acquire any assigned service area rights in any portion of the property, nor will **B-Y Electric** acquire any rights to provide electric service in the area or in any other area on the basis of the electric line construction allowed pursuant to this Consent and Agreement. B-Y Electric agrees that **NorthWestern** shall reserve the right, that should future equipment be installed at this location that is beyond the capabilities of this service **NorthWestern** shall have the first option to serve. Furthermore, this Consent and Agreement shall not be admissible in evidence before any court or commission, nor shall it constitute or establish at any time a precedent between **NorthWestern** and **B-Y Electric**.

NorthWestern consents to **B-Y Electric** providing a single phase **Electrical Service** to a Pressure Reducing Valve and Vault for as long as said Pressure Reducing Valve and Vault is used for the purpose intended and is located on following described property. Should the Pressure Reducing Valve and Vault cease to be used for the purpose intended all rights granted by this Consent and Agreement shall be **Terminated**.

The Pressure Reducing Valve and Vault will be located approximately Fifty-six feet (56') East and Seventy-four feet (74') South of the Northwest Corner of the Northwest Quarter (NW1/4) of Section Fourteen (S14), Township (Mission Hill South) Ninety-three North (T. 93 N.), Range Fifty-six West (R.56 W) of the Fifth (5th) Principal Meridian, Yankton County, South Dakota as shown on the attached Exhibit "A".

This Consent and Agreement is effective only after being approved by the Public Utilities Commission.
