1-3) For consistency, in Section 12.03 on page 2 under the "Special Conditions of Service" point 1, please remove the "5" year term in the list of contracts for a facility "desiring dependable service compensation" as the capacity payment for the 60 month, 5 year, contract is proposed at \$0.00.

RESPONSE:

Otter Tail understands your reasoning in requesting that Otter Tail remove the "5" year term in the list of contracts for a facility "desiring dependable service compensation" as the proposed \$0.00/kW capacity payment for the 60 month/5 year contract. However, there are two valid reasons why Otter Tail would like to leave the wording as originally submitted.

The first reason is that a customer could enter into a contract under Section 12.03 for a term of 5 years with no capacity payment, but with the energy payment portion of this section.

The second reason is that the capacity payment portion of this rate may change in subsequent filings. Using our previous example, the customer would be eligible under Section 12.03 to receive the capacity payment schedule if the capacity payment was greater than \$0.00/kW. Therefore, Otter Tail would prefer to keep the wording on this rate to reflect that possibility in the future.
