Legal Description of the Electric Service Territory Boundary between Oahe and Onida

Based on maps on file at the South Dakota Public Utilities Commission, the following represents the legal description of the electric service territory boundary shared between Oahe Electric Cooperative, Inc. (Oahe) and Onida Municipal Electric (Onida).

BEGINNING at the NW corner of Section 11 of Township 114 North (T114N), Range 77 West (R77W), Sully County,

THENCE continue south 1653 feet along the centerline of Highway 83,

THENCE continue east to the centerline of 4th Street,

THENCE continue south along the centerline of South 4th Street to a point where South 4th street intersects with the centerline of Ginseng Ave,

THENCE continue west 570 feet,

THENCE continue south 535 feet,

THENCE continue east to the centerline of 4th Street,

THENCE continue south along the centerline of 4th Street to the SW corner of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 11 of T114N, R77W,

THENCE continue east to the SE corner of the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 11,

THENCE continue north to the NE corner of the SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 2 of T114N, R77W,

THENCE continue west to the centerline of North 9th Street,

THENCE continue north 330 feet along the centerline of North 9th Street to the intersection of Evergreen Ave,

THENCE continue west to the centerline of Main Street in Section 2 of T114N, R77W,

THENCE continue south to a point where Main Street intersects with the northern line of the SW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 2,

THENCE continue west 615 feet,

THENCE continue south to the southern line of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 2 of T114N, R77N,

THENCE continue west to the NW corner of the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 2,

THENCE continue south to the point of intersection of a line extending west from the centerline of Bayberry Ave,

THENCE continue west to the western line of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 2 of T114N, R77N,

THENCE continue south to the SW corner of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 2,
