

# EXHIBIT A

## Legal Description of the Electric Service Territory Boundary between H-D and Whetstone

Based on a prior agreement dated the 28th day of May, 1976, signed by H-D Electric Cooperative, Inc. (H-D) and Whetstone Valley Electric Cooperative, Inc. (Whetstone), the following represents the legal description of the electric service territory boundary shared between H-D and Whetstone.

BEGINNING at Deuel/Grant County line at the SW corner of the SE  $\frac{1}{4}$  of Section 31 of Township 118 North (T118N), Range 50 West (R50W), Grant County,

THENCE continue east along the Deuel/Grant County border to the SE corner of the SW  $\frac{1}{4}$  of Section 32 of T118N, R50W,

THENCE continue north to the NE corner of the SW  $\frac{1}{4}$  of Section 32,

THENCE continue east to the SE corner of the NE  $\frac{1}{4}$  of Section 32,

THENCE continue south to the Deuel/Grant County border to the SW corner of Section 33 of T118N, R50W,

THENCE continue east along the Deuel/Grant County border to the SE corner of the SW  $\frac{1}{4}$  of Section 32 of T118N, R49W,

THENCE continue north to the NE corner of the SW  $\frac{1}{4}$  of Section 32,

THENCE continue east to the SE corner of the NE  $\frac{1}{4}$  of Section 32,

THENCE continue south to the Deuel/Grant County border to the SW corner of Section 33 of T118N, R49W,

THENCE continue east along the Deuel/Grant County border to the SW corner of Section 31 of T118N, R48W,

THENCE continue north to the NW corner of the SW  $\frac{1}{4}$  of the SW  $\frac{1}{4}$  of Section 31,

THENCE continue east to the NE corner of the SW  $\frac{1}{4}$  of the SW  $\frac{1}{4}$  of Section 31,

THENCE continue south to the Deuel/Grant County border to the SE corner of the SW  $\frac{1}{4}$  of the SW  $\frac{1}{4}$  of Section 31,

THENCE continue east along the Deuel/Grant County border to the SE corner of the SW  $\frac{1}{4}$  of Section 31,

THENCE continue north to the NE corner of the SW  $\frac{1}{4}$  of Section 31,

THENCE continue east to the SE corner of the NE  $\frac{1}{4}$  of Section 31,

THENCE continue south to the Deuel/Grant County border to the SW corner of Section 32 of T118N, R48W,
