- BEGINNING at the NE corner of the NW ¼ of the NW ¼ of the SE ¼ of Section 30 of Township 97 North (T97N), Range 71 West (R71W), Gregory County,
- THENCE continue west along the north boundary of the S ½ of Section 30 to a point of intersection with a line extending north from the centerline of Jackson Street,
- THENCE continue south 1256 feet to a point along the centerline of Jackson Street,
- THENCE continue west to the west boundary of Section 30 of T97N, R71W,
- THENCE continue southwest to the NW corner of the SE ¼ of the SE ¼ of Section 25 of T97N, R72W,
- THENCE continue south 271 feet,
- THENCE continue west 830 feet,
- THENCE continue south to the centerline of Highway 18,
- THENCE continue southeast along the centerline of Highway 18 to the north boundary of Section 36 of T97N, R72W,
- THENCE continue west to the NW corner of the NE 1/4 of Section 36,
- THENCE continue south to the SW corner of the NW ¼ of the NE ¼ of Section 36,
- THENCE continue east to the SE corner of the NE ¼ of the NE ¼ of Section 36,
- THENCE continue southeast, parallel to the centerline of Highway 18, 1566 feet to a point of intersection with the east boundary of the SW ¼ of the NW ¼ of Section 31 of T97N, R71W,
- THENCE continue northeast 226 feet to the centerline of Highway 18,
- THENCE continue southeast along the centerline of Highway 18 to a point 91 feet northwest from the east boundary of the SE ¼ of the NW ¼ of the SE ¼ of Section 31 of T97N, R71W,
- THENCE continue northeast 130 feet to the east boundary of the SE ¼ of the NW ¼ of the SE ¼ of Section 31 of T97N, R71W,

- THENCE continue north to the NE corner of the NE <sup>1</sup>/<sub>4</sub> of the NW <sup>1</sup>/<sub>4</sub> of the SE <sup>1</sup>/<sub>4</sub> of Section 31,
- THENCE continue west to the NW corner of the NE  $\frac{1}{4}$  of the NW  $\frac{1}{4}$  of the SE  $\frac{1}{4}$  of Section 31,
- THENCE continue north to the NE corner of the NW ¼ of the NW ¼ of the SE ¼ of Section 30 of T97N, R71W.
