## Legal Description of the Electric Service Territory Boundary between Charles Mix Electric Cooperative, Inc. and NorthWestern Corporation dba NorthWestern Energy

Based on a prior agreement dated the 22<sup>nd</sup> day of December, 1975, signed by Charles Mix Electric Association, Inc. and NorthWestern Public Service Co., the following represents the legal description of the electric service territory boundary shared between Charles Mix Electric Cooperative, Inc. and NorthWestern Corporation dba NorthWestern Energy.
