CONSENT AND AGREEMENT FOR ELECTRIC SERVICE IN ASSIGNED SERVICE TERRITORY OF ANOTHER ELECTRIC SUPPLIER

This Consent and Agreement is made between the City of Estelline (hereafter referred to as "Estelline") of P.O. Box 278, Estelline, South Dakota 57234, and H-D Electric Cooperative, Inc. (hereafter referred to as "H-D"), of P.O. Box 1007, Clear Lake, South Dakota 57226, to be effective approval by South Dakota Public Utilities Commission (PUC).

WHEREAS Estelline holds assigned territorial rights to provide electric service to the service site at 46587 SD Hwy 28, Estelline, South Dakota 57234, located in the East Half of the Northwest Quarter (E½NW¼), in Section Twenty-five (25), Township One Hundred Thirteen (113) North, Range Fifty-one (51), West of the 5th P.M., (Estelline Township), Hamlin County, South Dakota, and

WHEREAS RON GORDER, the owner of the above site, requires a three-phase service and requests the three-phase electric service and Estelline, the utility providing the service, does not provide three-phase electric service to the RON GORDER service site. Because of the expense to Estelline to extend a three-phase service to the RON GORDER site, Estelline consents and agrees to allow H-D to extend its line to supply the three-phase electric service to the service site requiring the three-phase electric service for RON GORDER, all pursuant to SDCL 49-34A-55 and pursuant to the provisions of this Consent and Agreement, and

WHEREAS this Consent and Agreement shall result in adequate service to the customer affected and shall promote efficient and economical use and development of the electric systems of Estelline and H-D,

NOW, THEREFORE, Estelline and H-D agree as follows:

1. Estelline consents and agrees to allow H-D to supply the three-phase electrical service at 46587 SD Hwy 28, Estelline, South Dakota 57234, located in the East Half of the Northwest Quarter (E½NW¼), in Section Twenty-five (25), Township One Hundred Thirteen (113) North, Range Fifty-one (51), West of the 5th P.M., (Estelline Township), Hamlin County, South Dakota.

2. All other service, other than the three-phase electrical service, shall be provided by Estelline.

3. The property described, above, excluding the three-phase service, above shall remain a part of the assigned service territory of Estelline, and H-D does not acquire any assigned service territorial rights in any of the foregoing property, except for the three-phase service, nor will H-D acquire any rights to provide electric service within the above described property, except for the three-phase service, or in any other area within Estelline's assigned service territory by virtue of the three-phase electrical line constructed to serve RON GORDER'S three-phase electrical service pursuant to this Consent and Agreement.

4. This Agreement shall remain in effect so long as H-D Electric Cooperative, Inc., its successors and assigns, provide service for the three-phase electric service to RON GORDER, his successors and assigns.

5. This Consent and Agreement shall take affect only upon approval by the South Dakota Public Utilities Commission. The parties shall cooperate to seek such approval.
