## NORTHWESTERN ENERGY'S PETITION TO INTERVENE

NorthWestern Corporation d/b/a NorthWestern Energy ("NorthWestern") hereby petitions the South Dakota Public Utilities Commission ("Commission") for intervention in the above-captioned proceeding pursuant to SDCL § 1-26-17.1, ARSD § 20:10:01:15.02 and 20:10:01:15.03. In support hereof, NorthWestern states as follows:

- 1. Dakota Plains Ag Center, LLC ("Dakota Plains") plans to construct a new grain handling terminal (the "Terminal") in Yankton County, South Dakota. The site of the Terminal is within the service territory of NorthWestern and Bon Homme-Yankton Electric Association, Inc.
- 2. On April 1, 2016, Dakota Plains filed a Petition for Temporary Electrical Service (the "Petition") pursuant to SDCL §§ 49-34A-56 and 58, in which it requested the Commission assign NorthWestern as the supplier of temporary electrical service to the area under development, including territory currently served by Bon Homme-Yankton Electric Association, Inc. NorthWestern is ready, able and willing to provide temporary electrical service to Dakota Plains during construction of the Terminal.
- 3. On April 7, 2016, the Commission noticed filing of the Petition on its Weekly Filings and established an intervention deadline of April 22, 2016.
- 4. On April 8, 2016, NorthWestern and Dakota Plains executed an Electric Distribution Service Agreement ("Agreement"). The terms and conditions of the Agreement

control NorthWestern's delivery of permanent service to the Terminal, if approved by the Commission. Accordingly, NorthWestern would provide temporary service to Dakota Plains in accordance with the terms and conditions of NorthWestern's tariffs.

- 5. NorthWestern's pecuniary interests will be directly and immediately affected by the Commission's decision on the Petition. NorthWestern desires to intervene in this matter to provide information regarding its ability to provide temporary electric service to the Facility.
- 6. Based on the foregoing, NorthWestern is an interested party in this matter entitled to intervening party status.

WHEREFORE, NorthWestern requests that the Commission grant this Petition to Intervene and allow NorthWestern to be granted party status in this proceeding.
