Dear Secretary Bose:

In accordance with Section 205 of the Federal Power Act, 16 U.S.C. § 824d and Sections 35.1 and 131.52 of the Federal Energy Regulatory Commission's ("FERC") regulations, MidAmerican Energy Company ("MidAmerican") hereby submits a Certificate of Concurrence to the filing made by ITC Midwest LLC ("ITC Midwest") in Docket No. ER16-1356-000. The filing in Docket No. ER16-1356-000 consisted of an executed Second Amended and Restated Transmission Interconnection Agreement ("Interconnection Agreement") between ITC Midwest LLC, Interstate Power and Light Company, Board of Water, Electric and Communications Trustees of the City of Muscatine, Iowa and MidAmerican.<sup>1</sup>

The Interconnection Agreement supersedes an earlier version of the agreement that was not executed by the parties, but approved by FERC subject to filing an executed copy of the agreement, which this Interconnection Agreement fulfills.<sup>2</sup>

### **I. Description of Filing**

This filing consists of Certificate of Concurrence (Attachment 1) and Tariff Record (Attachment 2) adopting the following rate schedule: **ITC Midwest LLC Rate Schedule No. 123.**

### **II. Proposed Effective Date**

MidAmerican respectfully requests that FERC make the Certificate of Concurrence effective at the same time as the Interconnection Agreement. ITC Midwest LLC requested and effective date of June 6, 2016. To the extent that it is determined that any requirements of 18 C.F.R. § 35 apply that have not been specifically addressed in this Certificate of Concurrence, MidAmerican respectfully requests waiver of such requirements.
