## **Dear Public Utilities Commissioners:**

There have been many questions about the proposed Dakota Range Wind development and the impact it will have on our community. Some people are concerned that their electricity prices will increase because of the wind project. From my research and my dealing directly with the developers, I know this is simply untrue. Wind technology has improved immensely in the last decade and there is good reason that wind development is thriving in South Dakota.

Wind energy is cheap, the fuel to run its generators, the wind, is free! Once construction of a wind farm is complete, the costs to maintain the turbines for the next two to three decades is relatively cheap. This keeps wind energy costs predictable and affordable. Buying wind allows Xcel Energy to keep their rates a bit lower for everyone, if they must raise rates, because other costs are rising, they won't have to raise them much because the wind in their system is predictable and won't experience cost fluctuations.

Some people are concerned that the wind tax credit is just going to put a bunch of money in certain people's pockets, but that's not true either. The tax credit offered by the feds is paid for in kilowatts hours generated. In other words, no one gets any discount on their taxes until the project is built and operating, and the discount is only available if the turbines are generating energy. What the tax credit really does is allow wind companies to sell their energy for less money – making it even cheaper for consumers like us.

The Midwest is harnessing this natural power source and wind farms are being developed all over the Midwest and South Dakota. Our community will benefit for decades to come and this sustainable power source will help to power tens of thousands of homes. The benefits of this project will be felt by the community for over three decades. The taxes produced from this farm will allow the county to not raise citizens taxes for many years and allow for improvement in schools and public safety also. There will also be dozens of landowners who will have steady payments for decades from the turbines and transmission lines on their property. Our community has not seen an economic boom like this in decades, and this wind farm will help our community for generations. I ask the commission approve Dakota Range Wind's permit.
