The receptors numbers changed and we no longer have a map to coordinate where the new receptor numbers are in relationship to the turbines.

I request the reason the receptor numbers changed and that we are provided with updated maps with the new receptor numbers and their locations. However, my preference would be to use the receptor numbers provided in the application as this will keep things clean and less confusing or hard to track down if needed at a later date.

Turbine 71 is within 1,000 feet of a non-participators property line. I do not feel Turbine 71 shift is safe. Ice throw, blade throw, fire risks, sleep-disturbing noise, flicker, infrasound and possible flooding from soil compaction causing excessive water runoff, and the loss of enjoyment or future use of property may all become issues for the non-participating landowner to the south. Turbine 71 is within a 1,000 feet of a nonparticipators property line.
