# SDDOT Right of Way Services Hwy 37 Bon Homme County, SD

Hwy 37 provided improvements of the existing 8.6 miles of 2 lane roadway corridor to widen the shoulders and expand the ditch cross section requiring addition Right-of-way Acquisition in Rural area.

Coordinated meetings with landowners to discuss impacts of the project, answer questions/concerns and effectively negotiate a fair and just offer. HDR ROW Staff also prepared, maintained and provided the client with a parcel tracking report to ensure the client was aware of any high priority items and/or changes that may affect the project schedule.

### Black Hills Energy Services, Pennington County, SD
