

Prevailing Wind Detailed Safety Information

1. Reasonable safety precautions for existing activities on or near the Project;

The Prevailing Wind Park, LLC will be constructed in an area that has very high agricultural activity. Items of concern are:

- a. The use of large farm equipment in close proximity to the construction/erection equipment, including excavations and trenching Barricades and warning tape will be used to protect all ground openings and to guard DO NOT ENTER work areas. All large construction equipment will be escorted as it moves across the site in part, to be observant of the agricultural activity.
- b. The use of herbicide and pesticide chemicals Land owners will be asked to supply chemical lists and time periods of use, in addition we will ask to be notified at specific application times. All personnel will be trained to be aware of any applications and notify site administration
- c. Possible night time activities during planting and harvesting seasons by the local landowners—reflective barricades and reflective tapes will show all disturbed ground activities. Good housekeeping requirements will prevent unseen material from being a hidden danger. In the event there is nighttime wind farm construction light banks will be utilized. All workers are required to wear high visibility clothing, with reflective strips, at all times. Management will be required to make after-dark drives prior to night time activity, and to add reflective posts to any dead-end road situation.
- d. Livestock activity Landowners/tenants will be continually updated on the locations of construction activity. If the livestock cannot be temporarily re-pastured, fences and barricades will be erected to protect the site personnel from aggressive animal behavior.
- e. High traffic usage of local roads, including sharing the roads with the large agricultural equipment site orientation will include instructions on the best practices for sharing the road all light vehicles should pull off to the side of the road to allow larger vehicles to pass (and early enough so the other driver will know you ARE pulling over). Bon Homme county has been requested to enhance stop signs coming out onto the highways, in close proximity to the laydown yard. CONSTRUCTION CROSSING AHEAD signs will also be utilized. A communication program will be established with the local authorities to inform on near-term planned construction locations.
- f. Private Land Hunting -High visibility clothing is a full time requirement of all construction personnel. In addition, when hunting activity is observed site management will be notified immediately to assess the safety of all persons.
- g. School Buses Continuous training, safety meeting topics and morning meetings will highlight that this rural area will see high school bus activity, and the proper responses to all school bus activity.
- h. South Dakota is now a Constitutional Carry firearm state This was enacted to enhance the safety of all SD residents. Even though within the law, no site personnel will be allowed to carry weapons, but panic should be avoided if a SD resident is seen carrying a fire arm.
- i. High voltage lines, buried energy lines extensive work, along with the SD 811 system, has gone into identifying known potential dangers in the project area. All overhead lines will be marked across the project to "look up" as well as all buried lines to prevent trenching/plowing into these areas

2. ANY KNOWN RESTRICTED ACTIVITY

a. All federal, state and local laws are in place and effective for the wind park. No other known activity is restricted, nor is any construction or operation SOP known to be prohibited.
