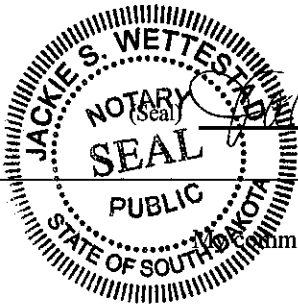

WHAT: Permit for Flying Cow Wind, LLC to Construct a 345 KV Transmission Line and Associated Facilities in Deuel County

WHEN: Monday, November 19, 2018, at 5:30 p.m. CST- CANCELLED

WHERE: Deubrook Elementary School Gymnasium, 695 Palisades Ave., Toronto, SD - CANCELLED

Pursuant to SDCL 49-41B-15 and 49-41B-16, the South Dakota Public Utilities Commission published notice of a public input hearing at the above time and place on an application to construct an approximately 10.42 miles of 345-kilovolt (kV) overhead transmission line, a substation, and associated facilities (Project) located entirely within Deuel County, South Dakota. The Project is proposed by Flying Cow Wind, LLC, a wholly-owned subsidiary of Roaring Fork Wind, LLC, the joint venture formed by subsidiaries of its affiliate Renewable Energy Systems Americas Inc., and Vestas Wind Systems A/S. The starting point of the transmission line for the Project is proposed to be located in Government Lot 2 of Section 34 in Township 114N, Range 47W, Norden Township. The ending point will be in the NW 1/4 of Section 22, Township 113N, Range 48 West, Scandinavia Township. The Project is expected to be in service by the third quarter of 2020.

On November 5, 2018, the Commission issued an order granting Flying Cow Wind LLC's request to Withdraw the Application and dismissed and closed the docket.

Pursuant to this Order, this Public Input Hearing is Cancelled.
