On October 25, 2018, NorthWestern Corporation (NorthWestern) filed revisions to the Standard Large Generator Interconnection Agreements contained in Attachment M of NorthWestern's Montana Open Access Transmission Tariff (OATT) and NorthWestern's South Dakota OATT. NorthWestern is removing Appendix G from each OATT's respective Attachment M in accordance with Order No. 827. The revisions are accepted for filing, effective December 26, 2018, as requested.<sup>2</sup>

The filings were noticed on October 25, 2018, with comments, protests, or motions to intervene due on or before November 15, 2018. No protests or adverse comments were filed. Notices of intervention and unopposed timely filed motions to intervene are granted pursuant to the operation of Rule 214 of the Commission's Rules of Practice and Procedure (18 C.F.R. § 385.214).
